Mr. Nelson called the meeting to order at 6:12 p.m.

MINUTES OF JULY 11, 2016 BOARD MEETING: 1) Motion made to approve the minutes of the July 11, 2016 Board of Trustees Meeting as written M/S/C Cosand/Stark. Mr. Padilla abstained.

PUBLIC INPUT: None

SELF DETERMINATION UPDATE: Mr. Meza reported that the Self Determination Committee continues to meet monthly. The committee has been focusing on training as things continue to move forward. DDS continues to work on the guidelines that will be provided to staff. There is hope that the program will be approved by the end of November. There has been some debate on how Person Centered Planning is interpreted. Person Centered Plan is going to be a large part of Self Determination. There are now 262 consumers and families that have expressed interest in the program. IRC will be allotted 244 spots to participate in the pilot program. The next committee meeting is scheduled for 6:00 p.m. on September 17 at the State Council San Bernardino office.

CHAIRPERSON'S REPORT: Mr. Nelson thanked IRC's staff, leadership team and Directors for doing such a good job handling the day to day tasks. He is happy to report that the Board's Inbox has been free of complaints which is an indication that IRC is moving in a positive direction. Mr. Nelson shared he has been attending the CAC meeting with his son and would like to encourage the Board to attend a CAC dance or upcoming event. He is also looking forward to the Another Way Toy and Food Drive. He would like to see the Board more involved in these events.

EXECUTIVE DIRECTOR'S REPORT: Ms. Johnson asked the Directors to introduce their new program managers. Ms. Webster introduced Mr. Giuseppe Ancona, Early Start Clinic. Mr. Meza introduced two new program managers: Ms. Demetria Lee, Riverside Adult Central and Hoang Nguyen, San Bernardino Foothill Mountain Adult. Mr. Garcia introduced three new program managers: Katie Lee, Riverside School Age Southeast, Felicia Valencia, Riverside School Age West and Gabriella Hernandez, West End School Age.

Ms. Johnson reported as of August 30, 2016 IRC had 32,245 active cases. This is a growth of 531 cases since June 1, 2016. Managers continue to interview for CSC positions and have hired 20 new employees as of July. Ms. Johnson thanked Mr. Urtz for taking the lead on building security. Mr. Urtz walks around the buildings, talks to staff and keeps in touch with the security team. Management received positive feedback after the front fence was removed. The next phase is to open the back gates then eventually take down the back fence. Restoration of building 3 has begun and contractor is hoping to have everything completed by the end of December. IRC had visits from two legislators. Senator Connie Leyva on July 7 and Assembly Member Cheryl Brown on August 12. Open Enrollment was held on August 30, 2016 at the Rock Church. Staff expressed their gratitude to the Board for offering such a generous benefit package. Ms. Johnson thanked Ms. Steuwer for all the work she did in preparing for Open Enrollment.

FINANCIAL REPORT: Ms. Steuwer stated that she did not prepare a Financial Report due to IRC receiving its C1 allocation at the end of August. Ms. Steuwer provided a summary of the new components in the Fiscal Year 2016-17 budget. 1) ABX 2 1 Section §4639.5 funding for staff. These funds are to be used to enhance staff salaries and/or benefits. These funds cannot be used to increase Executive Staff salary and/or benefits. They cannot be used to pay for unfunded retirement liabilities. 2) Allocation to improve Service Coordinators (CSC) caseload ratios. The allocation is estimated to pay for 28 CSC positions at base level. 10 have already been filled. The remaining 18 positions will be allocated to between the Children and Transitions Units and Adult Services Units. Children and Transition units will receive 8 and Adult Services will receive 10 of these positions. 7 new managers have been hired this year.

COMMITTEE REPORTS

- 1) **ANOTHER WAY:** Ms. Gonzales provided a written report and highlighted the following upcoming events: 1) The Annual Food Drive is scheduled for December 10th from 12:00 p.m. to 2:00 p.m. 2) 350 kids have been signed up for the Toy Drive scheduled for December 14th. The Christmas Tree with the kids wishes will be set up on November 1 in building 2 employee lounge. Sandals Church will be honored during the Toy Drive. 3) Strategic Planning & Team Building Retreat will be held on March 10, 2017. Another Way has invited IRC's Executive team and Board's Executive Committee to participate. 4) Walk & Rock 2017 is tentatively scheduled for September 23, 2017. The Board's attendance to any or all of these events is welcome.
 - a) **ANOTHER WAY RESERVE FUNDS**: The Another Way Committee is requesting the Board's approval to withdraw \$30,000 from the Another Way's investment account. Funds will be used for the Strategic Planning Retreat, update the Another Way website and replacing Christmas decorations lost due to the December 2 attack. **2) Motion made to approve** withdrawing \$30,000 from the investment account M/S/C Stewart/Cosand.
- 2) **VENDOR ADVISORY COMMITTEE**: Ms. McGuire provided a written report and announced that the VAC Committee has an opening for a Residential Level 4 and Behavior Mod representatives. The committee decided to eliminate the Behavior Mod position and have a Member at Large specializing in Behavior Mod attend join the Day Program subcommittee. The committee will also be working on revising the VAC Bylaws. Anyone interested in helping can contact Ms. McGuire for more information. The VAC voted to go dark in December. The next VAC meeting is scheduled for 10:00 a.m. on October 17, 2016 at Salem Chrisitan Homes in Chino.
- 3) **LEGISLATIVE REPORT**: Ms. Cummings provided a summary of pending legislation that may be of interest to the Board and vendors.
- 4) **CONSUMER ADVISORY COMMITTEE**: Mr. Ryan Nelson provided a written overview of the events from the past 8 months and shared information on some future events. Mr. Ryan Nelson invited the Board to attend a CAC meeting and/or event.
- 5) **MASTER TRUST COMMITTEE**: Mr. Britton announced Achieving a Better Life Experience (ABLE) Act has made it to California. California had their first meeting in August. ABLE is not expected to be available until 2017. Master Trust role would serve more of an agency and charge maintenance fee. There is no back end processing.

a) APPROVAL OF NEW MEMBER: Mr. Britton requested the Board's ratification of new voting member of the Master Trust Committee, Hon. J. Michael Welsh. Mr. Welch's biography was included in the Board's packet. 3) Motion made to accept Honorable J. Michael Welsh as a member of the Master Trust Committee M/S/C Asten/Padilla.

5. Presentation – walk through – PCP (person centered plan) template



The template is a redacted copy of a regional center consumer's person centered plan. Please see attached. The focus is on the person not on what the RC does or does not offer or fund. The template shows that there can be more than one FMS. The team is made up of people who the individual wants there. Maia asked everyone who we would invite to our person centered plan. There was a suggestion to consider professional staff who work with the individual.

Daniel – He said that there is a woman who he knows that has a son with autism, she would be someone he would invite to his meeting.

Rene – Stated his mom, entire family is his circle of support.

Wendy – Stated that her daughter shows her like & dislikes over a period of time.

Maia – Helps to develop goals & expectations for the individual

Bill – Discussed that the questions be given to individuals involved before the meeting.

6. Discussion Items (old business)

- a. Update on CMS waiver Don Meza there is no progress to report.
- b. Update on the number of interested consumers Don Meza reported that the current number of consumers interested in SD is 262. Don, also stated that IRC has 32,300 active consumer caseloads. Over the last quarter there have been 500 new consumers added to IRC caseloads. IRC staff is understanding more of the SD program and putting the word out to consumers and families.
- c. Update on venue Don Meza stated that IRC working to establish a new venue. Shannon Meehan said that the San Bernardino SCDD office will be moved to the building across the way. 625 Hospitality Way?

- Update on Temecula Fire: The deceased have all been formally identified. Investigation is still
 ongoing. IRC is providing consumer and vendor files for the investigator working on the case.
 IRC was informed that the fire is being investigated as a possible homicide. All inquiries are
 being referred to the investigator.
- 2. Executive Director's Review: Board Chair met with Executive Director and review was completed. The Board expressed how much they enjoy and appreciate working with the Executive Director.
- 3. Update on Building 3: Reconstruction has begun with an estimated completion date of December 31. Staff met with insurance adjuster. There were over 5,000 line items submitted. Additional information was needed. The flooring in sections A and B will be changed to vinyl instead of carpeting. The library will be used as the Board's meeting room. Section C will be used as a meeting or training room. Fence around building 3 will not be removed until the building is complete. Memorial memorabilia will be placed throughout building 3 or in a display case by the main entrance. An office or two may be used for MicroEnterprises and an office will be set aside for a kid's room. A grant request was submitted for an outdoor memorial. Staff events can be held between buildings 1 and 2 or in back parking lot. Some of the carpet in building 1 is being replaced because of glass shards surfacing. The receptionist expressed wanting to remain in the front lobby.
- 4. Discuss Recording Meetings: The Board Chair received 3 requests to resume recording Board Meeting. We will have the capability when we return to building 3. Anyone attending can also record the meeting. Everything the board receives in the Board Packet is available for anyone to review on line. Additional lighting was installed around building 1 and in the atrium. 27 cameras are also scheduled to be installed. During regular working hours, the cameras will be recording. Afterhours, the cameras will be activated by motion. Cameras were only installed outside of the building.

- 1. DDS Update: DDS emailed Lavinia and Keith requesting a meeting with the Board regarding IRC's probation. A tentative date and time was set for November 14 at 3:00 p.m. here at IRC.
- 2. Probation Training: A Board Training to go over IRC's probation has been scheduled for November 7 at 4:00 p.m.
- 3. Board Strategic Plan: Since IRC's operations is running smoothly, the Board can now focus on areas they can be of value. Attendance to the Another Way Toy and Food Drive can be beneficial to the committee. Grant applications tend to ask about Board participation. Staff have invited Board to their End of the Year Appreciation Event. Master Trust is currently not doing any marketing. The Board can help by informing people of the service and giving them the contact person's information. Having a Legislative Committee will also be beneficial.
- 4. New HR Manager: A new HR Manager has been hired and will start on Monday, October 24. Her name is Maria Harkin and she is from the San Bernardino Archdiocese. Ms. Harkins comes with a wealth of experience. She oversees the entire archdiocese of approximately 3,000 employees. She over oversees about 120 employees in her department. She will be a good fit for IRC.
- 5. Independent Audit Update: The auditors will be finished by the end of the week. The exit meeting will take place about the end of November. This audit will be the last audit for this firm. A Request For Proposal (FRP) was sent out in search of a new firm. The deadline to submit a proposal is October 31st. Proposals are to be submitted in a sealed envelope and will all be open in a group setting. Staff will invite a Board Member to participate in the opening. We are scheduled for a DDS Audit in April, 2017. IRC has not received the audit report for the last two audits from DDS.
- 6. CONSUMER TOTALS: As of November 1, 2016, we have 32,605 active cases. That is an increase of 360 cases since our last report in September. It is interesting to note that in June of 2000, we had an active caseload of 15,500 which means we have more that doubled in size since that time! We obviously continue to grow at a very fast pace.

STAFFING: We continue to advertise, interview and hire to fill any vacancies and are hiring to fill new growth positions. We currently have 673 employees which is up from 663 last reporting period.

NEW MANAGERS: We would like to welcome two new additions to our management team. First we would like to congratulate Kathy DeCoud on her promotion to Program Manager of the San Bernardino Upper Desert School Age Unit under Felipe Garcia. Kathy comes to this position from the Quality Assurance Unit. We would also like to welcome Maria Harkin to our management team. Maria is our new Manager of Human Resources under Steve Beckett and comes to us from the Diocese of San Bernardino. We are very pleased and fortunate to have them both join our team.

SECURITY UPDATE: In keeping with our effort to return to as much of the pre-December 2 atmosphere as we can, we did remove the fencing around the back parking lot at the end of September. We have received no complaints

SECURITY UPDATE: (cont)) no complaints from staff regarding this. We have also begun the installation of improved lighting and a camera surveillance system which should add significantly to our employees sense of security. There has been no reduction in the number of on-site security personnel (4), and no reduction anticipated.

BUILDING 3: Restorative construction continues in building three and it is reported that the work may be completed and ready for occupancy in early 2017. The fencing and mesh around building 3 will remain until restoration is complete. We continue to discuss how the space in building 3 will be used. See attached "press release" for additional information.

DECEMBER 2 ANNIVERSARY COMMEMORATION: Plans are being made and finalized for our 12/2 commemoration. Please see attached press release for more detailed information. We do anticipate a significant media presence but we want everyone to remember that this is not about IRC. Rather is it about remembering the victims. It will be open to the public but space and parking will be very limited. We are not inviting specific entities, speakers or guests as there are too many to include. We only risk offending the many we do not invite and again this is about the victims, not IRC. We will however present plaques to the local insurance company, golf course, Rock Church and Hernandez Center who accommodated and supported us on 12/2. Finally we have been in communication with San Bernardino County and the San Bernardino Mayor's Office in an effort to coordinate information about 12/2 preparations so that everyone is aware of our plans.

Inland Regional Center staff will come together for a moment of healing and reflection in memory of the victims of the December 2, 2015 attack.

(San Bernardino, CA. November 8, 2016) – On December 2, 2016, Inland Regional Center (IRC) will hold a brief memorial ceremony for IRC staff and guests to remember the victims of the attack that occurred on December 2, 2015. At 10:30 a.m., Lavinia Johnson, Executive Director of IRC, and Keith Nelson, Chairman of the IRC Board of Trustees, will speak to the staff and guests. Organizations that offered shelter to IRC staff immediately after the attack on December 2nd will be recognized. Shortly before 11:00 a.m., a moment of silence will be observed by those in attendance. Although the public may attend, parking and space will be limited.

In addition, California State University, San Bernardino announced that there will be a public ceremony on December 2, 2016 at 6:30 p.m. The community is invited to gather at Coussoulis Arena to continue to heal and show strength by honoring those impacted by the attack.

Ms. Johnson also announced that it is anticipated that IRC will begin to utilize the conference building in early 2017. The building has been closed since December 2015, primarily due to major water damage on the first floor. Ms. Johnson stated that, "The Executive Management Team is working closely with our landlord, California Housing Foundation, and their property management firm, Tiarna Real Estate Services, Inc., to complete the remodeling process." It has not yet been determined how the floor space will be used but it is anticipated that Coffee-N-More, a cafe that was housed in the building and frequented by IRC staff, will reopen. Also, the IRC Board of Trustees will resume holding their Board meetings in the building once the remodel is completed. There are plans to dedicate space to a memorial but the specifics have not been determined and remain under discussion.

Attached herewith is the Fiscal Year 2017 draft budget proposal for Operations and the projected budget for Purchase of Service (POS).

On September 12, 2016, we received the C-1 contract amendment from DDS. The total allocation for Operations including CPP is \$64,707,808, an increase of 14.13% compared to FY 2016 operations' final allocation (please see draft proposed operations budget). Included in the Ops allocation this fiscal year is ABX2 1 which is the bill that was passed to increase the funding in the Developmental Disability Services system.

Below are the new major assumptions/policy items that are included in the C-1 contract amendment:

- 1. ABX2 1 Section §4639.5 funding to provide salary increase, benefit increase, or both, for regional center staff. These funds shall not be used to provide salary or benefit increases to regional center executive staff; or for unfunded retirement liabilities.
- 2. Improve Service Coordinator Caseload Ratios funding for additional CSCs to improve caseload ratios; allocation was based on percent to total of Caseload Status 1 and 2, all ages.
- 3. Compliance with HCBS Regulations funds allocated for one (1) Program Evaluator position for each regional center.
- 4. Resources to Implement ABX2 1 funds allocated for each regional center for one (1) Employment Specialist position, and one (1) Cultural Specialist position.

A total of 82 new/growth positions are included in this budget, please see detail below:

The total allocation for Non-CPP (Regular) Purchase of Service (POS) is \$384,415,853. The total authorizations for POS as of October 31, 2016 is \$430,936,546 resulting in a projected POS deficit of \$46,520,693.

From July to September 2016, POS expenditures for 32,436 consumers is \$92,312,980. Service category with the highest average cost per consumer per month is the Home Care Program at \$7,946; followed by Community Care Facilities at \$4,249. Day Training has the highest number of consumers at 8,636; followed by Transportation/Transportation Contracts for a total of 6,748; and Respite has a total of 6,440 consumers (please see projected POS budget).

Inland Regional Center Community Engagement and Training Unit Board of Trustee Report November 2016

Good afternoon, and thank you for your time in reviewing this report.

In the month of September, the Community Engagement and Training Unit (CETU) was invited to present along with the Inland Empire Fathers Involvement Coalition at the 30TH Annual Children's Network Conference. The topic was "Fathering a Child with Special Needs." As well, the CETU Senior Training provided an in-service training to 75 new Police and Sheriff Deputies in September and 35 in October at the San Bernardino County Sheriff's Academy.

The CETU Senior Trainer provided a Self Determination Orientation to parents at the Riverside Library in September and another at the State Council on Developmental Disabilities in October. The team's Consumer Advocates participated in the San Bernardino Voters Accessibility Committee meetings, both in September and October, to ensure our consumers' rights and dignity is upheld this election year.

In the month of September, the CETU team held its first of three CAC Job Development work shops, where we partnered with In Roads Creative Programing, Premier Health and the CAC members to provide Application Assistance, Interview Etiquette and Dress for Success sessions. The sessions in October focused on practicing interview skills. The third and final session will focus on interview follow up skills, a guest speaker on Micro Enterprises and a graduation ceremony. Also, in September the CAC went bowling in Moreno Valley at Round One. Finally, the month of September was wrapped up with a trip to Blythe where trainings on How to Advocate for Yourself, How to Advocate for Your Child and Self Determination were offered.

October is traditionally a very busy month for the CETU. This year was no exception. In addition to our regularly scheduled meetings and trainings, we hosted informational booths at the Inland Empire Disability Coalition Expo, IEHP Disability Awareness Day, Montclair DPH special needs classroom and presented to Loma Linda University on Disability Awareness. In October, the CAC was hosted by Ryan and Keith Nelson and treated to a BBQ. This was a very popular event and we had several new consumers visit with the Advocates and enjoyed the company of the CAC members.

On November 19th is our annual IRC Fall Festival at San Manuel Stadium. This event is hosted by the IE 66ers baseball team. This year's event is from 11am to 2pm and everyone is encouraged to wear their favorite sporting team jersey.

VETOED BY GOVERNOR:

AB 1584 (Brown D) Public social services: SSI/SSP.

9/25/2016-A. VETOED ARCA Position: Support

Summary: This bill would reinstate the cost-of-living adjustment for State Supplementary Program for

the Aged, Blind and Disabled (SSP), beginning January 1 of the 2018 calendar year.

Veto Message Summary: This bills would commit us to spending every year. The budget process allows for all spending proposals to be weighed equally through public hearings, negotiations and, finally, approval of a balanced budget. This is the best way to evaluate and prioritize all new spending proposals, including those that increase the cost of existing programs.

SB 1385 (Leyva D) California Disaster Assistance Act: Inland Regional Center.

9/25/2016-S. VETOED

ARCA Position: Support if amended

Summary: The California Disaster Assistance Act generally provides that the state share for disaster project allocations to local agencies is no more than 75% of total state eligible costs, except for specified events for which the state share is up to 100% of state eligible costs. This bill would add the December 2, 2015, shooting that occurred at the Inland Regional Center to the list of events for which the state share of state eligible cost is up to 100%.

Veto Message Summary: I [Governor Brown] recognize the unique circumstances of this horrific terrorist attack. However, this bill sets the expectation that the state will assume all financial responsibility for future emergency costs. The General Fund cannot afford this precedent. The Office of Emergency Services will continue to work with the local agencies in San Bernardino to ensure that all eligible costs are reimbursed through the California Disaster Assistance Act.

AB 1824 (Chang R) Guide, signal, or service dogs: injury or death. 9/24/2016-A. VETOED

Summary: Under current law, it is an infraction or a misdemeanor for any person to permit any dog that is owned, harbored, or controlled by him or her to cause injury to, or the death of, any guide, signal, or service dog, as defined, while the guide, signal, or service dog is in discharge of its duties. Current law makes any person who intentionally causes injury to, or the death of, any guide, signal, or service dog, as defined, while the dog is in discharge of its duties, guilty of a misdemeanor. This bill would delete, from both crimes, the requirement that the guide, signal, or service dog be in discharge

of its duties when the injury or death occurs and would make these crimes applicable to the injury or death of dogs that are enrolled in a training school or program for guide, signal, or service dogs.

Veto Message Summary: Lowering the mens rea standard for one of the misdemeanors covered by this measure expands the scope of the current penal code which already is convoluted and unnecessarily complex. I believe that existing law provides an adequate deterrent and sufficient punishment.

AB 1930 (Lackey R) In-home supportive services: family caregivers: advisory committee. 9/30/2016-A. VETOED

Summary: Would, until January 1, 2019, establish the IHSS Family Caregiver Benefits Advisory Committee for the purpose of describing the availability of, and barriers to accessing, employmentbased supports and protections, as specified, and studying the impact of the lack of access to these supports and protections on individuals who provide supportive services to a spouse or as the parent of a recipient child.

Veto Message Summary: The In-Home Supportive Services Stakeholder Advisory Committee, with its composition of consumers, providers, labor representatives and advocates, has the ability and expertise to examine these issues and produce information necessary to advise the departments involved as well as the Legislature on this topic.

SB 547 (Liu D) Aging and long-term care services, supports, and program coordination. 9/22/2016-S. VETOED

Summary: This bill, among other things, would create the Statewide Aging and Long-Term Care Services Coordinating Council, chaired by the Secretary of California Health and Human Services, and would consist of the heads, or their designated representative, of specified departments and offices.

Veto Message Summary: These are important issues, but I'm [Governor Brown] not convinced that creating such an unwieldy state council would advance the goals we both share.

PASSED LEGISLATION:

ABX2 1 (Thurmond D) Developmental services: Medi-Cal: funding.

3/1/2016-A. CHAPTERED

Summary: Commencing July 1, 2016, among other things, this bill would increase rates and wages for certain developmental services providers and fund incentive payments for competitive integrated employment opportunities and internships for individuals with developmental disabilities. The bill would require DDS to submit a rate study to specified committees of the Legislature on or before March 1, 2019, regarding community-based services for individuals with developmental disabilities.

AB 54 (Olsen R) Disability access: construction-related accessibility claims: demand letters. 9/30/2016-A. CHAPTERED

Summary: The Construction-Related Accessibility Standards Compliance Act establishes standards for making new construction and existing facilities accessible to persons with disabilities and provides for construction-related accessibility claims for violations of those standards. Current law requires that a copy of the demand letter and the complaint be sent to the California Commission on Disability

Access. This bill would, in addition, require that information about the demand letter and the complaint be submitted to the commission in a standard format specified by the commission on the commission's Internet Web site.

AB 488 (Gonzalez D) Employment discrimination.

9/27/2016-A. CHAPTERED

Summary: Would authorize an individual employed under a special license in a nonprofit sheltered workshop, day program, or rehabilitation facility to bring an action under the California Fair Employment and Housing Act for any form of harassment or discrimination prohibited by the act. The bill would provide an employer against whom the individual brings this action with an affirmative defense by proving, by a preponderance of evidence, that the challenged action was permitted by statute or regulation and was necessary to serve employees with disabilities under a special license.

AB 796 (Nazarian D) Health care coverage: autism and pervasive developmental disorders. 9/23/2016-A. CHAPTERED

ARCA Position: Support

Summary: Deletes the sunset date Current law requires every health care service plan contract and health insurance policy to provide coverage for behavioral health treatment for pervasive developmental disorder or autism until January 1, 2017, and defines "behavioral health treatment" to mean specified services provided by, among others, a qualified autism service professional supervised and employed by a qualified autism service provider. This bill would delete the sunset date, thereby extending the operation of these provisions indefinitely. By extending the operation of these provisions, the violation of which by a health care service plan would be a crime, the bill would impose a state-mandated local program.

AB 1272 (Grove R) Criminal procedure: trial schedule conflicts.

7/25/2016-A. CHAPTERED

ARCA Position: Support

Summary: Current law requires a superior court to make reasonable efforts to avoid setting a trial for murder, sexual assault, child abuse, or a case being handled in the Career Criminal Prosecution Program on the same day that another case is set for trial involving the same prosecuting attorney. This bill would expand this requirement to include a trial involving an alleged offense against a person with a developmental disability.

AB 1553 (Irwin D) Savings plans: qualified ABLE program.

9/13/2016-A. CHAPTERED

Summary: Current federal law, the Stephen Beck, Jr., Achieving a Better Life Experience Act of 2014 (ABLE Act), encourages and assists individuals and families to save private funds for the purpose of supporting persons with disabilities to maintain their health, independence, and quality of life by excluding from gross income distributions used for qualified disability expenses by a beneficiary of a qualified ABLE program established and maintained by a state, as specified. This bill would modify the definition of "eligible individual." The bill would also exempt the ABLE Act Board from the above prohibition in the State Contract Act for a contract with a program consultant for the qualified ABLE program but would require such a contract to be publicly disclosed in a manner specified by the board prior to entering into the contract.

AB 1606 (Committee on Budget) Developmental services.

6/27/2016-A. CHAPTERED

Summary: Would require DDS to report quarterly to the Joint Legislative Budget Committee the estimated amount of General Fund expenditures used to backfill federal funding as a result of the decertification of intermediate care facility units at the Sonoma Developmental Center. The bill would also require, if the intermediate care facility units at the Fairview Developmental Center or the Porterville Developmental Center are decertified by the federal government in the 2016-17 fiscal year, the department to report quarterly to the Joint Legislative Budget Committee the estimated amount of General Fund expenditures used to backfill federal funding as a result of the decertification or decertifications.

AB 2212 (Harper R) Pupils: suspensions and expulsions: bullying: electronic acts: video.

9/21/2016-A. CHAPTERED

ARCA Position: Support

Summary: Current law prohibits the suspension, or recommendation for expulsion, of a pupil from school unless the superintendent of the school district or the principal of the school determines that the pupil has committed any of various specified acts, including, but not limited to, engaging in an act of bullying by means of an electronic act. This bill would expressly include a video within the definition of what constitutes an electronic act.

AB 2231 (Calderon D) Care facilities: civil penalties.

9/29/2016-A. CHAPTERED

ARCA Position: Concerns

Summary: Current law establishes the State Department of Social Services and sets forth its powers and duties, including, but not limited to, the licensure and regulation of community care facilities, residential care facilities for persons with chronic life-threatening illnesses, residential care facilities for the elderly, day care centers, and family day care homes. Current law authorizes the department to impose various civil penalties for a licensing violation under those provisions. This bill would, commencing July 1, 2017, increase the amount of civil penalties to be imposed for a licensing violation under those provisions, and would impose civil penalties for a repeat violation of those provisions, as specified.

AB 2371 (Frazier D) Voluntary contributions: Special Olympics Fund.

9/22/2016-A. CHAPTERED

ARCA Position: Support

Summary: Would allow a taxpayer to designate an amount in excess of personal income tax liability to be deposited to the Special Olympics Fund, which the bill would create. The bill would require moneys transferred to the Special Olympics Fund, upon appropriation by the Legislature, to be allocated to the Franchise Tax Board and the Controller, as provided, and to the State Department of Social Services for disbursement between the Special Olympics Northern California and the Special Olympics Southern California for the purpose of funding activities of the Special Olympics in support of children and adults with intellectual disabilities, as provided.

AB 2394 (Garcia, Eduardo D) Medi-Cal: nonmedical transportation.

9/25/2016-A. CHAPTERED

ARCA Position: Support

Summary: Current law provides for a schedule of benefits under the Medi-Cal program, which includes medical transportation services, subject to utilization controls. This bill, commencing July 1, 2017, would add to the schedule of benefits nonmedical transportation, as defined, subject to utilization controls and permissible time and distance standards, for a beneficiary to obtain covered Medi-Cal services. The bill would require these provisions to be implemented only to the extent that federal financial participation is available, and not otherwise jeopardized, and any necessary federal approvals are obtained.

SBX2 2 (Hernandez D) Medi-Cal: managed care organization tax.

3/1/2016-S. CHAPTERED

Summary: Would, on July 1, 2016, and until July 1, 2019, establish a new managed care organization provider tax, to be administered by the State Department of Health Care Services. The tax would be assessed by the department on licensed health care service plans, managed care plans contracted with the department to provide Medi-Cal services, and alternate health care service plans (AHCSP), as defined, except as excluded by the bill.

SB 3 (Leno D) Minimum wage: in-home supportive services: paid sick days. 4/4/2016-S. CHAPTERED

Summary: Would require the State Department of Social Services, in consultation with stakeholders, to convene a workgroup to implement paid sick leave for in-home supportive services providers and to issue guidance in that regard by December 1, 2017. The bill would authorize the department to implement that paid sick leave without complying with the Administrative Procedure Act. This bill contains other related provisions and other existing laws.

SB 586 (Hernandez D) Children's services.

9/25/2016-S. CHAPTERED

Summary: Current law prohibits services covered by the CCS program from being incorporated into a Medi-Cal managed care contract entered into after August 1, 1994, until January 1, 2017, except with respect to contracts entered into for county organized health systems or Regional Health Authority in specified counties. This bill would exempt contracts entered into under the Whole Child Model program from that prohibition and would extend to January 1, 2022, and until the evaluation required under the Whole Child Model program has been completed, the termination of the prohibition against CCS-covered services being incorporated in a Medi-Cal managed care contract entered into after August 1, 1994.

SB 873 (Beall D) Revised Uniform Fiduciary Access to Digital Assets Act.

9/24/2016-S. CHAPTERED

ARCA Position: Support

Summary: AB 691 of the 2015-16 Regular Session would enact the Revised Uniform Fiduciary Access to Digital Assets Act, which would authorize a decedent's personal representative or trustee to access and manage digital assets and electronic communications, as specified. Among other provisions, AB 691 would provide that a custodian of digital assets, and its officers, employees, and agents, are

immune from liability for an act or omission done in good faith and in compliance with the act. This bill would specify that this immunity does not apply in a case of gross negligence or willful or wanton misconduct.

SB 884 (Beall D) Special education: mental health services.

9/29/2016-S. CHAPTERED

ARCA Position: Support

Summary: Current law separately requires the Controller, in consultation with the Department of Finance, the State Department of Education, and specified other entities, to propose the content of an audit guide for purposes of carrying out financial and compliance audits for local educational agencies. This bill would require the audit guide to include audit procedures to review whether specified funding, which the bill would subject to existing state and federal audit requirements, for educationally related mental health services required by an individualized education program received by local educational agencies was used for its intended purpose in the 2016-17 fiscal year, and would require these audit procedures to be included in future fiscal years if recommended by the Controller, as specified.

SB 996 (Hill D) Property taxation: welfare exemption.

9/29/2016-S. CHAPTERED

ARCA Position: Support

Summary: The California Constitution authorizes the Legislature to exempt from taxation property that is used exclusively for religious, hospital, or charitable purposes, and is owned or held in trust by a nonprofit entity. Pursuant to this constitutional authority, existing law partially exempts from property taxation property used exclusively for rental housing and related facilities, if specified criteria are met. Current law limits the total exemption amount allowed to a taxpayer, with respect to a single property or multiple properties for any fiscal year on the sole basis of the application of this criterion, to \$20,000 of tax. This bill would increase that total exemption amount allowed to \$10,000,000 in assessed value, with respect to lien dates occurring on and after January 1, 2017.

SB 1072 (Mendoza D) Schoolbus safety: child safety alert system.

9/27/2016-S. CHAPTERED

ARCA Position: Support

Summary: Current law requires the county superintendent of schools, the superintendent of a school district, or the owner or operator of a private school that provides transportation to or from a school or school activity to prepare a transportation safety plan containing procedures for school personnel to follow to ensure the safe transport of pupils, as prescribed. This bill would require that plan to include procedures to ensure that a pupil is not left unattended on a schoolbus, school pupil activity bus, or youth bus, and procedures and standards for designating an adult chaperone, other than the driver, to accompany pupils on a school pupil activity bus. The bill would additionally require a charter school to prepare this plan.

SB 1221 (Hertzberg D) Firefighters: interaction with persons with mental disabilities.

9/14/2016-S. CHAPTERED

ARCA Position: Support

Summary: Current law requires the Commission on Peace Officer Standards and Training to establish a continuing education classroom training course related to law enforcement interaction with mentally disabled persons and to make the course available to law enforcement agencies in California. This bill would authorize the commission to make the course available to the State Fire Marshal. The bill would delete an obsolete reporting requirement and make a conforming change.

SB 1226 (Beall D) Regional centers: audits and reviews.

9/21/2016-S. CHAPTERED

ARCA Position: Support if amended

Summary: Current law requires an entity that receives payments from one or more regional centers to obtain an independent audit or independent review report of its financial statements based upon the amount it receives from the regional center or regional centers during the entity's fiscal year. This bill would, commencing January 1, 2018, instead require the entity to obtain an independent review report of an independent audit of its financial statements based upon the amount it receives from the regional center or regional centers during each state fiscal year.

SB 982 (McGuire D) State Department of Developmental Services: developmental centers. 9/24/2016-S. CHAPTERED

Summary: Would require the State Department of Developmental Services to seek to modify the contract in existence on January 1, 2017, for the conduct of a movers longitudinal study to include specified requirements, including, among others, a requirement that at least 250 individuals who meet certain criteria participate in the study. The bill would require the department to annually submit interim reports to the Legislature regarding the study. The bill would require, upon the completion of the study, the department to submit the study to the Legislature, as specified.

SCR 98 (Beall D) California's community-based developmental services system: 50th anniversary. 8/16/2016-S. CHAPTERED

ARCA Position: Support

Summary: This measure would recognize the year of 2016 as the 50th anniversary of California's community-based developmental services system, and would reaffirm the commitment of the Legislature to support this system. This measure would declare the importance of ensuring a sustainable system that protects the rights of individuals with developmental disabilities.

SCR 110 (Mendoza D) Brain Injury Awareness, Treatment, and Prevention Month.

5/4/2016-S. CHAPTERED

ARCA Position: Support

Summary: This measure would designate the month of March 2016, and each year thereafter, as Brain Injury Awareness, Treatment, and Prevention Month, and would encourage public officials and the citizens of California to observe the month with appropriate activities and programs to raise awareness about the symptoms of, treatments for, and ways of preventing, traumatic brain injuries.

SCR 122 (Beall D) Autism Awareness Month.

5/10/2016-S. CHAPTERED

ARCA Position: Support

Summary: This measure would designate the month of April 2016 as Autism Awareness Month and would encourage residents to show support for autism awareness by lighting their homes, businesses, schools, and places of worship with blue light bulbs.

SR 38 (Mitchell D) Relative to the 2015 Special Olympics World Games. 7/9/2015-S. ADOPTED

Summary: The Personal Income Tax Law imposes taxes based upon taxable income and also imposes interest and penalties with regard to those taxes under specified circumstances, including a penalty for the underpayment of estimated tax. This bill would provide that addition to tax shall not be imposed if the applicable percentage for the earned income tax credit for the taxable year was less than the applicable percentage for that credit for the preceding taxable year and would impose a penalty, in conformity with federal law, for failure to be diligent in determining eligibility for the earned income tax credit, as specified.

SANDIS System Updates: Improvements continue and new resource options have become available to case management staff through the iPad mobile devices. The CSCs currently access SANDIS via a mobile APP on iPads. SANDIS will be releasing a Web based version called "SANDIS 7" sometime in 2017. IRC is one of the biggest users of SANDIS software in the state, and our willingness to go forward with our iPads and Mobile SANDIS have been helpful in the ongoing development of the software. IRC has been invited to participate as a pilot regional center for "SANDIS 7" as early as February 2017. We are excited about this possibility and look forward to testing this new software.

Medicaid Waiver (MW): Staff continue to work hard to add new cases to the MW program. DDS has not established a new goal for IRC, so we are using the most recent goal of 11,662 active consumers as our guide. Currently, IRC has 11,788 consumers enrolled which is well above the goal. The MW team has been working diligently to assist CSCs to maintain the highest level of documentation. The MW staff continue to add new "Deeming" cases as well. In addition, the MW staff will have a new task where they will begin to review the new, HCBS "1915i" cases, which broadens the scope of MW program eligibility to our consumers. For the team to handle the additional responsibilities, we will be expanding the staffing with a new Senior Case Manager, and additional support staff to handle the administrative overload.

Self Determination (SD): The SD Advisory group continues to meet monthly. On October 26, 2016, a statewide meeting/conference call was held to discuss the latest updates of the SD program deployment. Attached to this report are the meeting minutes of the IRC SD Advisory meetings held in August and September 2016. The emphasis of the advisory group is to bring about awareness to the SD programming option. The interest list is being maintained for families interested in participating in Self Determination at IRC and continues to grow. IRC has 269 consumers/families that have expressed an interest in the SD program.

Inland Regional Center Children & Transition Services November 14, 2016 IRC Board of Trustees Report

Submitted by Felipe J. Garcia IRC Director of Children and Transition Services

School Age and Transition staff have now mostly settled into their new units since the reorganization of the Riverside School Age Units as well as the addition of a new Transition Unit in the San Bernardino County area. Since my last report another Program Manager was hired, Kathy DeCoud, to back fill for the Upper Desert School Age Unit. This unit was previously supervised by Program Manager Keniece Tillman who was asked to oversee the San Bernardino School Age unit. The changes were necessary to meet the increasing caseloads in IRC's catchment area. Kathy DeCoud has been with IRC for 10 years and demonstrated through interview process that she had the skills needed to work with our school age CSC's and the families. Kathy has hit the ground running and is working closely with families to address any concerns and or needs in the Upper Desert of the San Bernardino County area.

As the anniversary of December 2nd is near, many Program Managers are working closely with their staff to ensure that questions are answered in regards to any memorial services IRC may conduct. IRC staff is resilient and throughout the year has demonstrated that we are a family and stick together through the good and the bad. School Age and Transition Staff have organized activities to include all neighboring staff. For example, this year alone we have hosted two "all floor" potlucks. Different units bring food items and invite each other's units to participate and take the time to get to know each other over a meal. This was initiated by our Early Start units and quickly gained popularity with the School Ange and Transition units. The overall theme here is getting to know each other and encouraging staff to work further to develop a sense of community and family. I believe that having this will help staff get through this rough time some may be experiencing.

Update: Transition of Behavior Health Therapy from Regional Center system to Medi-Cal

Inland Regional Center (IRC) continues to meet with both Inland Empire Health Plan (IEHP) and Molina Health Care in efforts to transition all existing Behavior Health Therapies (BHT's) such as Applied Behavior Analysis (ABA) services currently funded by IRC to the Medi-Cal system. The process has been an undertaking which is a collaboration between IRC, IEHP, Molina Health care and recently Kaiser Medi-Cal. We have successfully transitioned 1,397 consumers to date. The deadline for transition has been extended until early 2017 by the Department of Health Care Services and the Department of Developmental Services.

- Added two Senior Liaison positions, which will assist the team with placement, trainings, investigations and initial writing of unit guidelines.
- QA has finished reorganizing the Special Incident Reporting process, making it more streamlined and less dependent on a paper process.
- We are using three sites for our Community Care Facility trainings. All trainings have been secured for the rest of the year.
- Continue to collaborate with the Department of Developmental Services, the Department of Public Health and Community Care Licensing (CCL). Met with CCL this month to review upcoming legislative changes.
- Provided several vendor trainings on the topic of WIAO and CMS.

Resource Development and Transportation Unit

- Tesa Patterson, Program Manager has separated from the agency.
- Dalila and I continue to supervise and lead the team, until a replacement Program Manager is secured.
- Working with San Gabriel Pomona Regional Center (SGPRC) for Joint trainings for vendors and staff.
- Working with Harbor Regional Center and SGPRC to develop day programs that will meet the CMS changes.

Other Duties

- Secured two new programs under the ABX2-1 POS Diversity Funding. Presentation on the two programs will be at the Board Meeting.



Intake, Early Start, Clinical Services and The Early Start Family Resource Network Board of Trustee Report September/October, 2016 Submitted by Treva Webster

The Intake Unit is working diligently to not only handle the hundreds of new, and re-eligibility intake assessments each month, but they are also to re-vamp the process to make it easier for individuals and their families, as well as more efficient for staff. They are working on ideas for improved information and additional forms for the IRC website too.

The Early Start Clinic Unit takes incoming calls regarding individuals from birth to 36 months. Then, if appropriate, the little one is evaluated for eligibility for Early Start Services.

The four Early Start Units focus on more than just development, but on the social, emotional and mental health needs of infants and toddlers. There are approximately 4,400 children receiving Early Start services per month.

The Clinical Services Unit includes Pharmacology, Nutritional and Dental consultants. They help the CSC's to identify and find resources for individuals needing those types of services.

The Early Start Family Resource Network (ESFRN) staff provides parent-toparent support and helps families in the community who need more information and resources that will benefit children who have developmental disabilities. This is important for all families so the ESFRN also has resources for non-English speaking families


