MINUTES OF JANUARY 9, 2017 BOARD MEETING: 1. Motion made to accept the minutes of the January 9, 2017 Board of Trustees Meeting M/S/C Cosand/Page. Ms. Stark abstained.

#### **PUBLIC INPUT:**

- 1) Alex Rodriguez, IRC Consumer is requesting IRC open their library as soon as possible.
- 2) Dimpna Rodriguez, mother of a 28 year old consumer with autism. Ms. Rodriguez inquired as to when is IRC going to implement a well structured program with personnel having a high understanding of people with autism. She states her son and his colleagues can be productive if only given the chance. IRC needs personnel to make the distinction between having a disability and having the ability.
- 3) Maria Ellen Hernandez, mother of an IRC consumer and coordinator of the Fiesta Educativa Conference presented Mr. Felipe Garcia a plaque of appreciation for all the help and support IRC has provided to their conference in 2015 and 2016. Ms. Hernandez expressed her appreciation to IRC and looks forward to the reopening of building 3.

**SELF DETERMINATON UPDATE:** The minutes of the November and January meetings were provided in the packet.

**CHAIRPERSON'S REPORT:** Mr. Nelson announced the confirmation hearing for Nancy Bargmann is scheduled for Wednesday, March 22. Mr. Nelson is submitting a letter in support of Ms. Bargmann. The Board will be holding a Special Board Meeting on March 15<sup>th</sup>.

**EXECUTIVE DIRECTOR**: Ms. Johnson reports as of the end of February, IRC reports 32,828 active cases. That is an increase of 175 from January. IRC continues to advertise, interview and hire to fill any vacancies. Building 3's restoration construction continues and we are hoping to occupy the building in late April or early May. Ms. Johnson introduced and welcomed Eric Hammler, Program Manager for the Resource, Development and Transportation team, and Liliana Garnica, Diversity Outreach Coordinator.

**FINANCIAL REPORT**: Ms. Steuwer provided a brief overview of IRC's Purchase of Service and Operations budget.

- APPROVAL OF IRC INDEPENDENT AUDIT: The Executive Committee met with Windes, CPA firm. CPA had the opportunity to interview the Board absent of any staff members. The financial statement presents fairly in all respects. 2). Motion made to approve the independent audit ending June 30, 2016 as presented M/S/C Asten/Padilla. Staff was advised to release a copy of the audit to Union Bank and to the Department of Developmental Services.
- 2. APPROVAL OF MASTER TRUST INDEPENDENT AUDIT: The financial statement for Master Trust presents fairly in all respects. 3) Motion made to approve the Master Trust audit ending June 30, 2016 as presented M/S/C Cosand/Stark.
- 3. RATIFY GIVING CHF DRAFT AUDIT FOR BOND DISCLOSURE PURPOSES: Ms. Steuwer reported that California Housing Foundation (CHF) needed a copy of the draft audit for Bond Disclosure purposes by March 1. The Executive Committee agreed to meet on February 25 to review the audit. - 3. #### 3. Public Comment

Peter Atwood commented about his experience with Inland Regional Center in regards to a pending due process hearing that he is advocating for a consumer and the consumer's family. He expressed his frustration about the IRC not allowing public access to the hearing.

Bill commented that it would be helpful to explain to the public what the SDAC is and the purpose of our committee meetings are for. That the IRC board meetings are a better venue for complaints about procedures and policies.

## 4. Self-determination program updates (SCDD, IRC)

Maia talked with Judy Marks regarding CMS approval. Per Judy Marks they anticipate that CMS approval will be soon. CMS is concerned about the FMS rate structures, other technicalities, clarification about inclusion and respite. There were questions regarding specialized therapeutic services not covered by insurance or Medi-Cal. CMS needed more clarifying language from the state. Regional Centers statewide should be preparing to start trainings for staff and families, including webinars. DDS is recommending inclusions of parents and advocates in trainings. DDS is encouraging RCs and SDACs should be working together to start trainings. Don stated that the DDS is waiting on response from the CMS to get started on the trainings. Don also said no formal trainings yet, trainings have been done to increase awareness of Self Determination Program with both staff and consumers. Vickie also commented that the when the Medicaid Waiver was implemented it changed the way IPPs were done. There were a lot of different things that had to be met to qualify for federal monies. Now CMS is requiring IPPs to be conducted in Person-Centered-Plan and not just about making sure all the boxes are checked.

## 5. Presentation – Public Testimony for Purchase of Service (POS) Disparity Data stakeholder meetings by OCRA

Irene Padilla presented information regarding stakeholder meetings. There were handouts regarding the actual numbers of where the disparities exist and consumer categories that are or are not utilizing services or areas where consumers needs are not being met. Other handouts



included information about stakeholder meetings and who they are for and providing public testimony. IRC consumers and families have the opportunity to speak at a stakeholder meeting held on March 30, 2017 at 550 E. Hospitality Lane, Suite 100, San Bernardino, CA 92408 English 5:00-6:00 PM and Spanish 6:00-7:00 PM CJ Cook is IRC public relations/community engagement coordinator.

# Executive Director's Report May 2017

**CONSUMER TOTALS:** As of April 25, 2017, we have 33,417 active cases. That is an *increase* of 589 cases since our last report in March when we were at 32,828. It should probably be noted that in the first quarter of the year, we had 391 transfers in from other regional centers while only transferring out 129.

**STAFFING:** We continue to advertise, interview and hire to fill any vacancies and are hiring to fill new growth positions. We currently have 720 employees which is up from 704 last reporting period (a net increase of 16 employees). We also have identified an additional 8 employees that will be starting in May although 7 long-term employees will be retiring in July. 478 of our employees serve in the capacity of a case manager (Consumer Service Coordinator, Early Start Case Manager or Case Management Trainee).

**BUILDING 3:** Restorative construction continues in building 3. Unfortunately we are not anticipating occupancy until June. The fencing and mesh around the building will remain until restoration is complete. As mentioned in previous reports, how the space in the building is to be used is still under discussion but we do anticipate that the coffee shop will return and of course the board meetings will return. We do not intend to have any formal ceremony marking the opening.

**DDS LIAISON:** We would like to announce that Denise Thornquest has been permanently assigned to IRC as our DDS liaison. Denise also works with the LA area regional centers and we look forward to working with her.

**DDS AUDIT:** We are currently in the middle of our annual DDS audit. This began on April 24th and it is anticipated that it will continue into the latter part of this month.

SPIRT OF VOLUNTEERISM AWARDS: Finally we would like to recognize and congratulate three of our employees, Sandra Guzman, Marie Harris and Eric Anderson for being honored at the Spirit of Volunteerism Awards luncheon at Disneyland on April 24. We are all very proud of them. They were recognized for their work with Another Way. We would also like to recognize and thank Andrea Gonzales for her work and leadership of Another Way and for nominating our employees for this award.

Re: Operations & POS Spending as of April, 2017

Attached herewith is the Fiscal Year 2017 spending for Operations and Purchase of Service (POS).

We received our C-2 preliminary allocation on April 28, 2017. The C-2 Ops Non-CPP allocation is \$170,890; and Ops CPP of \$72,120. The C-2 POS Non-CPP allocation is \$4,222,934; and zero allocation for POS CPP.

For the month of April, total gross expenditures in Operations is \$3,212,589. Other sources of revenues (interest income, ICF SPA income, and other income) received as an offset to expenditures is \$51,733. The net expenditures in Operations for the month is \$3,160,856.

The year-to-date spending for Personal Services is \$42,109,982; and for Operations, it is \$8,883,417. Total year to date net expenditures in Operations is \$50,993,399. The budget balance remaining is \$14,596,081 which is approximately 22.25% of the total allocation received from DDS. Thus far, Operations spending is aligned with the budget allocation.

For Purchase of Service (POS), the total expenditures for the service month of March 2017 paid in April 2017 is \$34,257,938. The breakdown of this amount is:

Out of Home Care: \$10,466,223
Day Programs: \$13,016,764
All Other Services: \$10,774,951

The total projected POS spending as of April 30, 2017, is \$396,096,552. Currently, the total non-CPP allocation received from DDS is \$388,638,787; estimated ICF-SPA receipts is \$16,913,359. Total projected revenues from all sources (DDS & SPA) is \$405,552,146 which is higher than projected POS spending of \$396,096,552; thus, a surplus is projected at \$9,455,594

Inland Regional Center Community Engagement and Training Unit Board of Trustee Report May 2017

Good afternoon, and thank you for your time in reviewing this report. Since my last report to you Community Engagement and Training Unit (CETU) has provided 40 outreaches, including attending Grassroots Day in Sacramento, two New Staff Orientations and 12 continuing education unit trainings. As well, we have been very busy with several other projects, such as website redesign, revamping New Staff Orientation, revamping the 'Mentor' Program, and Diversity Outreach efforts to address the Purchase of Services (POS) disparity.

Over the last couple of months, we have come up with a refreshed layout and color scheme for the website, inlandrc.org. The new site is being built on a test area of the server until all content is finalized and ready to move over later this year. Two major sections have since been completed, consolidating the information from various sections of the current website into a more fluid, easy to understand format. Here is an excerpt from our new copy: "At IRC, we aim to uphold the highest standards of integrity and transparency, in providing services to our Consumers. This page has been created in accordance with our Transparency and Access to Public Information policy. Our goal is to connect our Consumers, their families, and the community with information about how IRC conducts business and manages funds, while addressing the needs of a diverse population. Information about agencies that provide oversight to IRC and advocacy for our Consumers can also be found here."

Much research was done to determine the best way to deliver information to our consumers and their families, taking cues from DDS and other regional centers. We have consulted with Quality Assurance (QA) and Research Development and Transportation Unit (RDTU) on implementing our next section, regarding Service Providers. Another addition is a new and improved calendar function, which is now easier to sort and find events, and is optimized for mobile viewing. We will continue to work on refining the aesthetics of the new site, dialing in functionality, as well as meeting our deadlines for timely completion and launch date of July 1, 2017.

Over time, New Staff Orientation (NSO) has changed to fit the growing needs we have of our workforce. This has included a more streamlined layout, an emphasis on areas that require in-depth discussion and participation, and the utilization of technology. We have made some major changes that are geared toward providing our staff with the tools they require to be successful and to ensure we are handing over well-trained staff to the case management and administrative units. Starting with new hires in June 2017, we are making some exciting changes for employees entering our doors.

We have also revamped the 'Mentor' program; this is where new staff are paired with seasoned Mentors. Now, Mentors will have clearer instructions of what is expected of them when working with a new employee. In an effort to make the mentorship process more consistent, we have created monthly checklists (taking employees through their first 6 months of employment) with foundational skills that must be taught. Program Managers (PMs) are being asked to play an integral role in this process by supplementing instruction in areas where content mastery has not been achieved and/or request the training team provide a refresher.

Purchase of service disparity efforts among our Autism and Hispanic consumers are under way with the completion of the Autism Parent Education Program (APEP) and Fiesta Familiar referral process. Currently, three school age units are offering both APEP and Fiesta Familiar programs to families with no Purchase of Services. Fact sheets on APEP and Fiesta Familiar have been created and sent to the three Program Managers of these units to distribute to their CSCs. The fact sheets are intended to inform Consumer Service Coordinators about the programs to better explain and offer the programs to their families. As of today April 25th, a total of seven APEP referrals have been approved and sent to Fiesta Educativa. A total of 580 consumers have been identified among the three school age units as having no Purchase of Services.

- Category Reports were as follows:
  - Day Programs- Meeting was held on 04/05/17 at OPARC. Vendors received training on Paid Internships. Next Meeting will be on June 14th, 2pm at TBD.
  - O Health Facilities- Vendors are requesting assistance with the SIR portal system, as many of them are using Therap (database system) which helps them generate the report, but it cannot be uploaded to IRC's SIR portal, which means they are duplicating their work. The group discussed HS 231 reporting and the fact the Department of Health utilizes medical issues not necessarily developmental diagnoses. Michelle is terming out in June 2017, and a replacement is being requested. Next Meeting is scheduled for May 17<sup>th</sup> at Peppermint Ridge, time TBD.
  - o Infant/Children Programs- Absent, No Report.
  - Residential- At their last meeting, Vince Toms met with the service providers that were interested in working on Aging in Place, with the result being that service providers would need to make a request to change their level of care, for safety. Service Providers stated that they are having a hard time with Day Program and Transportation vendors who are sending clients home when they have a behavior, rather than trying to deescalate the situation. Service Providers also asked about Day programs adapting to the needs of consumers with Dementia. Next Meeting-TBD
  - Respite Programs- Absent, No Report.
  - SLS- The group met on 04/13/17 at Unlimited Potential in Upland. They discussed the Paid Internship program through Regional Center. The group will be holding a training for service providers on proper case note taking. They are requesting resources for parenting skills and IHSS training. Next Meeting TBD.
  - O Specialist/Support Programs- Last meeting was held in February. There are concerns among the group that Service Coordinators are telling service providers that authorization for services have been completed, but when the service provider attempts to bill, they are told that the authorizations are not in the system. Next Meeting is June 14<sup>th</sup>- time and place TBD
  - O Transportation- Last meeting was held on March 16<sup>th</sup>. The group discussed that each of them have to update their numbers on the Department of Transportation website. They also discussed reviewing contracts. A resource was offered to any for profit vendor looking for a tax credit- GoBiz.com. The group also discussed the impact of the gas tax increase. Next meeting is scheduled for June 17<sup>th</sup> at the Back to the Grind Coffee House.
  - Vocational- Last meeting was held on April 12<sup>th</sup> at OPARC. Vince Toms, and DOR representatives were there to discuss HCBS changes. IRC will still be using the federal version of the HCBS survey to do program visits, until the California plan is approved. IRC

is working with SGPRC on a new program design layout that includes the HCBS regulations. The group discussed the paid lunches for Supported Employment Groups, and the protocol for it. DOR reviewed the process for clients under the age of 25. It was also announced the schools will be involved in the paid internship program, and will be looking for vendors to complete the job coaching hours. - Legislative Report- Jennifer Cummings provided a worksheet that lists the current bills and which ones to pay attention to. Including: AB 1607, AB 1610, AB 1380, AB 959 and SB 283.
- CASACC- Amanda McGuire discussed the recent trip to Sacramento with IRC for Grassroots day.
  There were 11 total visits completed by the IRC group. And the most touching/impactful thing
  was the aluminum foil dinosaurs provided by CJ, but created by a program participant that were
  left with each Assembly member or Senator. IRC was one of 17 Regional Centers that attended.
  There are 21 total in California.
- Old Business- Vince Toms, IRC updated the group on several items:

**Re:** Amendment of Bylaws

Pursuant to the prior authorization of the Board, IRC's Bylaws need be amended to allow the Master Trust Committee to handle accounts established under the ABLE Act. Therefore, I am proposing that ARTICLE VIII, Section 4 of the Bylaws be amended as follows (new language in red):

## ARTICLE VIII - COMMITTEES Section 4. MASTER TRUST COMMITTEE.

The Master Trust Committee administers the Master Trust of California which is comprised of separate trusts administered as special needs trusts or other private trusts for persons diagnosed with developmental disabilities throughout the State of California. Any two (2) Trustees on this committee who agree a proposed action would violate a fiduciary responsibility owed by the Trustee, may exercise a veto, which is controlling. The Corporation is a trustee on private trusts created by court order, a consumer, a consumer's family or by a will. This committee has the discretion to release, or refuse to release trust funds on behalf of a beneficiary and to fulfill serving in a fiduciary relationship to each trust beneficiary and these Bylaws constitute the Board's ongoing approval and ratification of the actions of the Master Trust Committee in doing so. The Master Trust Committee may administer trusts anywhere in the State of California.

The Master Trust Committee is also authorized to establish and/or assist in establishing ABLE accounts through any of the ABLE Act programs established by any state that accepts applicants from California for those persons diagnosed with developmental disabilities and to

assist any such individuals with the administration of and/or distributions from their ABLE accounts to the extent permitted by law.

The members of the Master Trust Committee require specialization in the fields of public benefits, medicine, law, developmental disabilities, and finance. Due to the level of expertise required, members may include persons not on the Board, who are invited after approval by a majority vote of the Trustees then in office to sit on the Master Trust Committee. There are no term limits for the members who are not Trustees. In addition, the Executive Director, Associate Executive Director, General Counsel and Chief Financial Officer of the Corporation are *ex officio* non-voting members of the Master Trust Committee. The Trust Administrator for the Master Trust of California shall serve as the Chairperson. The members of this committee will select a Vice-Chairperson, who must be a Trustee. The meetings of this committee are not open to the public as this is a corporate affairs committee.

WHEREAS, in compliance with Government Code (Gov't C) § 7522.56, the Board of Trustees of Inland Counties Regional Center, Inc. (IRC) must provide CalPERS this certification resolution when hiring a retiree before 180 days has passed since his or her retirement date; and

WHEREAS, Robert Britton will be retiring from IRC in the position of Trust Officer for the Master Trust of California, effective July 7, 2017; and

#### ROBERT BRITTON CONSULTING CONTRACT

This CONSULTING CONTRACT ("Agreement") is entered into effective July 8, 2017 by and between Inland Counties Regional Center, Inc. ("IRC") and Robert Britton ("Consultant"), all of whom may be referred to in this Agreement, individually or collectively, as Party or Parties.

#### **RECITALS**

- **A.** Consultant has been employed by IRC in the position of Trust Officer for the Master Trust of California.
- **B.** Consultant is retiring from IRC in the position of Trust Officer for the Master Trust of California effective July 7, 2017.
- C. IRC and Consultant desire to utilize Consultant's unique experience, training and knowledge as the Trust Officer for the Master Trust of California to provide assistance to and perform certain duties for the Master Trust of California as set forth herein in order to maintain a continuity of services to the beneficiaries of the trusts administered by the Master Trust of California during the restructuring of the Master Trust of California, its operations and the delegation of the Trust Officer's duties among other Master Trust of California staff and the General Counsel as a result of the retirement of Robert Britton from the position of Trust Officer for the Master Trust of California.

#### TERMS AND CONDITIONS OF CONSULTANT'S DUTIES

- 1. **Period of Employment.** IRC agrees to employ Consultant on a month-to-month basis for a period not to exceed six (6) months beginning on July 8, 2017, subject to the termination provisions in section 4.
- Duties and Responsibilities. In order to maintain a continuity of services to the 2. beneficiaries of the trusts administered by the Master Trust of California, Consultant shall continue to perform the functions of Trust Officer for the Master Trust of California on a part-time basis as follows: Under the direction of the General Counsel and the Master Trust Committee, shall provide general oversight for Trust Administration and Trust Operations of the Master Trust of California, a pooled special needs trust, serving clients of any of the state's Regional Centers. The Trust Officer is responsible for all aspects of the administration of the Master Trust program, while maintaining a high level of customer service and appropriate levels of fiduciary and transactional risk management. The Trust Officer is also responsible for the oversight of the Trust Operations, to include insuring the integrity of the Trust Accounting process. Consultant shall also provide guidance on the restructuring of the Master Trust of California, its operations and the delegation of the Trust Officer's duties among other Master Trust of California staff and the General Counsel. Consultant shall devote his best efforts to the performance of his duties under this Agreement and shall report directly to the General Counsel.

#### 3. Compensation.

- **a.** Hourly Rate/Number of Hours. Consultant will be paid a rate of \$52.8049/hr. Consultant will work no more than 16 hours per week and no more than 960 hours in the fiscal year.
- **b. Invoices.** Consultant shall submit an invoice by the 10th day of each month for any and all work performed during the preceding month. The invoice shall provide a description of each task performed, the amount of time for each task, the amount charged for each task and the total amount charged for all of the work detailed in the invoice. Consultant's time is to be billed in increments of tenths of an hour (e.g., .1, .2, .3, etc.) for each task performed. All invoices shall be submitted in Word, Excel or PDF format and shall be sent by e-mail to IRC's General Counsel, Steven Beckett, at <a href="mailto:sbeckett@inlandrc.org">sbeckett@inlandrc.org</a>. IRC agrees to pay each contractually compliant invoice pursuant to its usual and customary procedures for the payment of vendor invoices.
- **c.** No Other Benefits or Compensation. Consultant shall not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to the above hourly rate of pay.
- d. Expenses/Travel. Consultant shall not incur any travel expense or any other expense or cost in performing any work under this Agreement without the prior written consent of IRC's General Counsel or Executive Director. For any such expenses that are approved, IRC shall reimburse Consultant for such expenses in accordance with IRC's standard expense reimbursement policies.

#### 4. Termination of Employment.

- **a.** By Death. This Agreement shall terminate automatically upon the death of Consultant. IRC shall pay to Consultant's beneficiaries or estate, as appropriate, any compensation then due and owing as of the date of death. Thereafter, all obligations of IRC under this Agreement shall cease.
- **b.** By IRC or Consultant. Either Party may terminate this Agreement at any time and for any reason, with or without cause, by providing the other Party with thirty (30) days advance written notice. IRC shall pay to Consultant any compensation then due and owing through and including the date of termination. Thereafter, all obligations of IRC under this Agreement shall cease.
- 5. Vendor Status. Consultant will comply with IRC's vendorization requirements that are applicable to Consultant. Consultant's vendor number, if not already issued, will be issued upon completion of the vendorization process.

In the event the Internal Revenue Service, the California Franchise Tax Board or any other governmental authority or agency should question or challenge the independent contractor status of Consultant with respect to the work performed under this Agreement, the Parties mutually agree that both Consultant and IRC shall have the right to participate in any discussion or negotiation occurring with such authority or agency, regardless of who initiated such discussions or negotiations.
- c. Consultant understands and agrees that Consultant shall pay all applicable taxes related to any payments under this Agreement and that IRC will not withhold any taxes from any payments that are due Consultant under this Agreement.

#### GENERAL TERMS AND CONDITIONS

- 7. **Inconsistencies.** In the event of any inconsistencies between the policies and procedures of IRC and the provisions of this Agreement, this Agreement shall govern.
- 8. Independent Legal Advice. Each of the Parties to this Agreement has received independent legal advice from attorneys of their own choice with respect to the advisability of executing this Agreement or had an equal opportunity to do so.

- 13. Good Faith. The Parties to this Agreement agree that they will not do anything that will interfere with the performance of this Agreement by any other Party to the Agreement, or which will adversely affect any of the rights and benefits provided for herein.
- 14. Binding Effect. This Agreement shall inure to the benefit of and be binding upon each of

No collateral, parallel or side agreements, representations, or warranties have been entered into between the Parties. Any new agreements between the Parties shall be in writing and signed by all Parties.
- 16. Waiver. A waiver by any Party of any of the terms and conditions of this Agreement shall not be deemed or construed to be a waiver of such term or condition in the future, or of any subsequent breach. Any custom or practice which may grow up between the Parties in the administration of this Agreement shall not be deemed or construed to waive or lessen the right of either Party to insist upon strict performance in accordance with all of the provisions of this Agreement.
- 17. Captions. The captions of the sections of this Agreement are solely for the convenience of the Parties, are not a part of this Agreement, and shall not be used for the interpretation of any provision of this Agreement.
- 18. Attorney's Fees/Costs. The Parties to this Agreement shall each bear their own costs and attorney fees with respect to the preparation and execution of this Agreement. In any action, lawsuit, arbitration or other legal proceeding, whether in law, contract or equity, including any appeal, which is undertaken to enforce or interpret this Agreement or any provision thereof, the prevailing party shall be entitled to an award of reasonable attorney's fees and costs, expert fees and costs, mediation fees and costs, arbitration fees and costs, and statutory costs.
- 19. Severability. In the event that any provision of this Agreement should be held to be void, voidable, or unenforceable, the remaining portions hereof shall remain in full force and effect.

This Agreement, and any ambiguities or uncertainties contained herein, shall be equally and fairly interpreted and applied for the benefit of and/or against each of the Parties hereto, and shall be construed without reference to the identity of the Parties preparing this Agreement, with the express understanding that each of the Parties participated in the negotiations and preparation of this Agreement or had an equal opportunity to do so.
- 21. California Law and Venue. This Agreement shall be construed in accordance with, and be governed by, the laws of the State of California. Any action or proceeding brought to

enforce or interpret this Agreement shall be brought in the San Bernardino County Superior Court, Central District.

Beckett, General Counsel, at IRC's then principal place of business. Any notice to Consultant shall be given in a like manner and, if mailed, shall be addressed to Consultant at Consultant's address as shown in Consultant's vendor file. Consultant shall be obligated to notify IRC in writing of any change of address. For the purpose of determining compliance with any time limits in this Agreement, a notice shall be deemed to have been duly given (a) on the date of delivery, if delivered personally on the Party to whom notice is to be given, or (b) on the third business day after mailing, if mailed to the Party to whom the notice is to be given in the manner provided in this section.
- **23. Counterparts.** This Agreement may be executed in any number of counterparts, each of which shall be deemed an original and all of which together shall constitute a single, integrated instrument. A faxed, photocopied, or PDF copy of a signature shall have the same force and effect as an original signature.

## Director Adult Services Report May 2017 Respectfully submitted by Don Meza

**SANDIS System Updates:** SANDIS will be releasing its Web based version called "SANDIS 7" sometime in 2017. IRC is one of the biggest users of SANDIS software in the state, and our willingness to go forward with our iPads and Mobile SANDIS have been helpful in the ongoing development of the software. The SANDIS team is currently "beta testing" the product at San Diego Regional Center and IRC hopes to have first use of the software by early fall 2017.

Medicaid Waiver (MW): Staff continue to work hard to add new cases to the MW program. DDS has not established a new goal for IRC, so we are using the most recently received goal of 11,662 active consumers as our guide. Currently, IRC has 12,349 consumers enrolled which puts us at 687 cases above the DDS goal that was set in June 2016. The MW team has been working diligently to assist CSCs to maintain the highest level of documentation. The MW staff continue to add new "Deeming" cases. MW staff will have a new task where they will begin to review the new, HCBS "1915i" cases in April 2017. This is expected to be a heavy task for MW staff that will add 7,500 consumers to the program. This new program broadens the scope of MW program eligibility to our consumers and helps bring in additional Federal dollars.

Self Determination (SD): The SD Advisory group went dark in March 2017. The most recent meeting of the Self Determination Committee was held on April 25, 2017. Attached to this report are the meeting minutes of the IRC SD Advisory meeting held in February 2017. The emphasis of the advisory group is to bring about awareness to the community of the SD programming option. CJ and IRCs Community Engagement team have held SD Orientation meetings in Barstow, Hesperia, Palm Desert and Blythe in the past few months. An interest list is maintained of consumers interested in participating in Self Determination at IRC. There has been little forward movement in the past few months as the State awaits a response from CMS regarding the approval of the proposed Self Determination program.

## Inland Regional Center Children & Transition Services May 08, 2017 IRC Board of Trustees Report

Submitted by Felipe J. Garcia IRC Director of Children and Transition Services

Greetings, Children, and Transition services continue to grow at a rapid pace. Our statistics are as follows: Currently under School Age and Transition services we have 15,433 consumers in total. School Age has 9,919 and Transition has 5,514 cases. There are 204 active caseloads of which 134 are in School Age and 70 are in Transition. We are working together as a team to meet the needs of our families for situations in where we may lose a CSC due to normal attrition. For those situations, we assign cases on a temporary basis to existing CSC's so that the families have a point of contact until we can hire vacancies. School age and Transition units work closely together to provide the best possible service to our families.

Recently, we have put together a team for our Behavioral Services which is housed under the School Age and Transition department. This team is responsible for overseeing almost all of our Behavioral Services referrals for the agency at large. Such referrals include Applied Behavior Analysis (ABA) services, Behavior modification services, request for 1:1 services at Day Program, Day Care and or Board and Care homes, Specialized Intensive Training Services (SIT) and Co-pay assistance program. Recently this team provided a training to our School age and Transition staff on the Co-pay referral process. This process itself may be complicated because it involves contacting our consumer's insurance plans, obtaining forms such as Explanation of Benefits (EOB's), income information from the family (to ensure they qualify for Co-pay/Co-insurance/Deductible assistance). This team serves a unique role for our families.

#### Update: Transition of Behavior Health Therapy from Regional Center system to Medi-Cal

Inland Regional Center (IRC) continues to meet with both Inland Empire Health Plan (IEHP) and Molina Health Care on a bi-monthly basis. At this time, the transition of all existing Behavior Health Therapies (BHT's) such as Applied Behavior Analysis (ABA) services currently funded by IRC to the Medi-Cal system has been completed. IRC, IEHP and Molina agencies continue to work together to ensure that all participants receive continuity of care.

The Workforce Innovation and Opportunity Act (WIOA) has been a major undertaking that involves our School Districts, Department of Rehabilitation, and IRC. In summary, this act states that any consumer under the age of 24 needs to be assessed for gainful employment and can no longer participate in sub minimum wage jobs. IRC meets with all parties monthly to discuss the needs of our consumers. There is a referral process that has been established and agreed upon to assist our consumers be appropriately assessed for work opportunities. On April 20, 2017, there was a cross training at the Corona City Library to train all our IRC Transition staff on the referral process for consumers who will be affected by WIOA.

Community Services has had a series of changes over the last year, to ready the vendor community to meet the Center for Medicaid and Medicare – Final Rule Changes coming in March of 2019. There have been several new positions added. There have also been several positions filled, because of staff promoting or leaving the units. The overall direction of Community Service is to provide quality customer service to our prospective and current vendors. We must create and keep high quality vendors and do so with consistency and mutual respect. I strongly believe we have the pieces in place to make a strong push to March 2019, and beyond. The following will detail the changes and status of both Quality Assurance and Resource Development.

#### **Quality Assurance**

Replacement and additional staff:

-2 CPL as of April 28, 2017

#### Goal:

Continue to improve efficiencies in policies and procedures in the tasks mentioned above.

As our team evolves, continue to teach, coach, and guide new and seasoned staff to continue to support one another as a team. Encourage the importance of IRC's mission and provide excellent customer service through "strength based modules", promote a safe working environment, and hostile free fun atmosphere.

#### General items:

- -Working with IT to launch Webinars-including trainings for small groups and large groups...this will allow information and trainings to be provided on an ongoing basis via web and in person.
- -First online seminar training will cover SIR's with the support of IRC SIR coordinator...tentative date is May of 2017.
- -Attended QA/RDTU meeting to network with other Regional Centers regarding placements and improve consistencies regarding policies and procedures for all regional centers.
- -On board for Crisis Home to open soon...worked with Resource, DBH, DDS, Licensing, CP, and Stacy and her team regarding plan on how to maximize consumer's quality of life and integrate into community. Next meeting is 4-26-17.

- -Upon request, staff trainings at IRC unit meetings regarding QA services and Mental Health meetings. The staff have attended 2 unit meetings thus far.
- -Working on updating QA procedures in writing.
- Partnered with IRC Legal to improve documentations including working with Client's Rights Advocates.
- -Conferences call with vendors and ICF department to improve communication and Health and Safety of consumers. Improvements have been noted.

- -Install Fox-it program to assist in entering SIR's.
- -Follow up with CP sending letters regarding delayed reporting and improve turn time in accordance with regulations.
- -Provide technical assistance to care providers in need.

This will allow the CP's to have the info immediately. The tool has been implemented starting 4-3-17 and has created a cost savings for the agency.

- -Held meeting with CJ, Amelia (Community Resource), Eric, Meredith, and Christina regarding proposed press release of vendor needs, as Board and Cares, RCFE's and children homes are needed.

-Partner and discuss situations, issues, concerns. Had a quarterly meeting with the two agencies with all staff on 4-19-17.

#### ARM rate:

- -All liaisons worked with their providers to assure appropriate ARM rate was implemented per their request and number of consumers in home.
- -Partnered with Vendorization, POS, Terry, DDS, and Directors to implement spreadsheet and documents for ARM rate accuracy.
- -Training to CP regarding ARM rates and regulation updates.

#### Medicaid Waiver and Mentor Audit:

-complied with deadline to support "Action Plan" on recommendations from DDS.

#### Goal:

-Continue to improve efficiencies in policies and procedures in the tasks mentioned above.

As our team evolves, continue to teach, coach, and guide new and seasoned staff to continue to support one another as a team. Encourage the importance of IRC's mission and provide excellent customer service through "strength based modules", promote a safe working environment, and hostile free fun atmosphere.

#### **Resource Development and Transportation Unit**

- > The TSR training has been completed w/all our pilot groups and we now have all our pilot groups now completing transportation request via TSR in SANDIS. We have provided training to almost the entire agency (Transition and Adult units). The last unit will be trained this week and everyone will be completing transportation request via TSR.
- ➤ Have attended a managements seminar on 3-28-17. Training was "Transitioning from staff to Supervisor". Purchased an account w/Fred Pryor so that I could attend trainings for the next 12 months. The goal is to attend one training a month if time permits.
- ➤ Consulting w/ SGPRC (Aaron C.) and CVRC (Aaron O). Meeting w/Aaron O on 5-10-17 here at IRC and Aaron C on 5-23-17.
- ➤ Working w/the behavior team here on changing the behavior portion of program design checklist so that it is in more simple language. Create a template that could be used for requirements of a Behavior Support Plan (BSP) which would also include the supplemental 1:1 (The problem that I see is that the language needs to simple so that the people who are implementing the plan understands what it means, most programs have a Behaviorist writing there plans but that still does not mean that the person implementing the plan understands the actual plan. Once that is complete, a training will be provided on the BSP to all the team so that everyone is trained on this portion which means all resource specialist can review program designs for all facilities (L2, L3, L4). Currently everyone can review them up until that portion and once they get to the behavior portion it is given to Meredith to review. Once this training is complete we can be more efficient as a team in terms of completing the review of program designs so that they do not have to be reviewed by so many people and getting bounced back to the potential providers because everyone will be able to review a program design from start to finish.
- > Changing to new provider orientation to make it more efficient.
- ➤ I also want to change the checklist for the program design so that we could take out the hypothetical section. Other regional centers are not doing it and it really does not serve a purpose because it basically is asking the potential provider to apply their behavior plan to a hypothetical consumer when they have already demonstrated the necessary information in the behavior plan support section (This is the part where most vendors have problems and it is something that is just our requirement). Again, this something that I would like to look at over

- the next year to condense the checklist some and ensure that we are a little more efficient and effective overall.
- > Completed my first evaluation w/Dalia and continuing to obtain training from her on evaluation and overall leadership.
- Working closely with team on modeling good customer service. Example: I worked w/Meredith on providing her some technical assistance on completing the program design in which she has been working on since 2009 on 3/2. Worked w/Rosie and Mrs. Brown (the one who contacted Nancy Bargman) on her program design in 3/17. I am doing the same thing w/transportation on Wed (3/17) Cara, Maggie and myself had a transportation provider which we assisted w/their application. On 4/24, I worked closely w/Sharon and Linsey by having a transportation provider come in and could model good customer service in addressing concerns w/the provider as well as provide technical assistance w/routing. I'm doing a lot of modeling by the team can see how I interact w/potential vendors, provide technical assistance and basically just letting the vendors know that we are excited to work with them. I would like to do this w/every staff over the course of the year as it is important in terms of increasing the customer service that we provide to potential and current vendors in fact it is critical.
- > Resource Staff has now gotten their additional monitors to assist w/reviewing program designs to increase efficiency.
- Attended a CCP plans training here at IRC presented by DDS on inputting the requested information into the request for funds as they relate to CPP.
- > Generated list of all providers who rates are above our median rates.
- > Generated list of all contracts that would be over 250k.
- > Submitted proposal for Transportation team to take over bus passes.
- > Compliance in Riverside is ongoing.
- ➤ Identify needs for CPP projects for FY 17-18. Completing the request for those funds the first week in May.

Meeting w/DDS auditors on 4/27 to discuss CPP, RFP process and other questions related to Resource and Transportation that they might have for me.

#### Goals for next year:

- > Condense the residential checklist, as I mentioned above.
- > Improve the culture of team so that we are working as a more unified team.
- Continue to develop protocols and processes for the way that we do things so that we all have the knowledge. This will help with having everyone help in areas of need, when we need it because the process will be uploaded on the shared drive that we all have access to. I have done this already with the contracts process for Transportation and Resource.
- Work with the transition PM's on a needs survey in all areas.
- > Continue to take management seminars/trainings to add to my skill set to meet the needs of the unit and topics that relates to areas where we as a team could improve (I'm still observing the unit to see what those would look like and what we need).
- > Continue to do staff development.
- > Continue to strengthen our relationship with QA, Vendorization, POS, the other regional centers and DDS.
- > Develop our housing specialist position, so that staff could focus more on the housing aspect of the job and projects related to affordable housing. This can be accomplished with the addition of a new staff person starting next fiscal year. They will absorb the specialists current "other duties as assigned."

#### **RECENT EVENTS:**

Grassroots Day was held April 5, 2017 at the State Capitol. Seventeen regional centers were in attendance and 100 legislative meetings were held to promote awareness and support for individuals with developmental disabilities and the regional center system. IRC representatives met with the following Legislators and/or their Staff: Sen. Roth, Asm. Cervantes, Sen. Morrell, Asm. Reyes, Asm. Steinorth, Sen. Stone, Asm. Obernolte, Asm. Melendez, Asm. Mayes, Asm. Medina, Sen. Leyva.

The next ARCA/Regional Center Legislative Committee meeting is scheduled for May 30, 2017.

Representatives from Master Trust, Revenue and Legal Affairs met with three San Bernardino Superior Court Probate Judges on April 12, 2017 to discuss streamlining procedures for handling Master Trust cases in court and provided general information about Inland Regional Center and conservatorships.

Jennifer Cummings is scheduled to provide a presentation to San Bernardino Bar Association probate attorneys on May 24, 2017 to share general information about Inland Regional Center eligibility, services and conservatorships.

#### **LEGISLATION:**

AB 1380 (Santiago D) - Developmental services: regional center services.

Current Text: Introduced: 2/17/2017

Location: 3/13/2017-A. HUM. S.

Calendar: 4/25/2017 1:30 p.m. - State Capitol, Room 437

- 1. Requires DDS to do review of in-home respite provider rates and determine if adequate
- 2. Requires regional centers to reviewing vendor contracts every two years
- 3. New requirement for respite providers on at least 85% on direct service expenditures (employee wages)
- 4. Requirement related to hiring respite providers background, fingerprint, criminal history limitations, hiring limitations

SB 399 (Portantino D) - Health care coverage: pervasive developmental disorder or autism.

Current Text: Amended: 4/17/2017

Location: 3/14/2017-S. HEALTH Calendar: 4/26/2017 1:30 p.m. – Room 4203

Expands the definition of "qualified autism service professional" to include behavioral service providers who meet specified educational, professional, and work experience qualifications. Would authorize the substitution of specified education, work experience, and training qualifications, or the substitution of specified credentialing or certification, for the requirement to meet the criteria set forth in regulations adopted by the State Department of Social Services, as specified. Would also require providers to pass a background check, as specified, in order to meet the definition of a qualified autism service professional or a qualified autism service paraprofessional.

#### AB 5 (Gonzalez Fletcher D) - Employers: Opportunity to Work Act

Current Text: Introduced: 12/5/2016 Location: 4/20/2017-A. APPR.

The bill would require an employer with 10 or more employees to offer additional hours of work to an existing nonexempt employee before hiring an additional employee or subcontractor. Would require an employer to post a notice of employee rights and to maintain certain documentation. The bill would authorize an employee to file a complaint for violation of these provisions with the division and to, in the alternative, bring a civil action for remedies under the act.

SB 283 (Wilk) – RC Eligibility Current Text: Amended: 4/6/2017

Location: 3/28/2017-S. APPR.; Calendar: 5/1/2017 10 a.m. – Room 4203

Would modify the definition of "developmental disability" as a disability that originates before an individual attains 22 years of age, continues, or can be expected to continue, indefinitely, and constitutes a substantial disability for the individual. ARCA is requesting amendments to eliminate median rates and once again permit regional centers to provide start-up funding for needed community programs.

AB 15 (Maienschein R) – Denti-Cal program: reimbursement rates

Current Text: Amended: 3/23/2017 Location: 3/21/2017-A. APPR.

Would require the State Department of Health Care Services, for the 2017–18 fiscal year, to double Denti-Cal provider reimbursement rates for the 15 most common prevention, treatment, and oral evaluation services based on the average rates per service established in the 2015–16 fiscal year. The bill would appropriate for the 2017–18 fiscal year such an amount as may be necessary to double the reimbursement rates from the Healthcare Treatment Fund to the department, as specified.

#### AB 27 (Melendez R) – Violent felonies: sex offenses

Current Text: Amended: 3/22/2017

Location: 3/14/2017-A. APPR. Calendar: 4/26/2017 9 a.m. – State Capitol, Room 4202

Current law classifies certain felonies as violent felonies for purposes of various provisions of the Penal Code. This bill would define as violent felonies rape, sodomy, penetration with a foreign object, or oral copulation, if the victim was unconscious, if the victim was incapable of giving consent due to intoxication, if the victim was incapable of giving legal consent because of a mental disorder or developmental or physical disability, if the victim submitted to the act under the belief that the person committing the act was someone known to the victim other than the accused, or if the act was accomplished against the victim's will by threatening to use the authority of a public official for purposes of the specified sentencing enhancements.

#### AB 67 (Rodriguez) – Violent and nonviolent felonies:

Current Text: Amended: 3/22/2017

Location: 3/14/2017-A. APPR. Calendar: 4/26/2017 9 a.m. – State Capitol, Room 4202

Adds PC § 286 (h) to the list of violent felonies:

PC 286 (h), "Any person who commits an act of sodomy, and the victim is at the time incapable, because of a mental disorder or developmental or physical disability, of giving legal consent, and this is known or reasonably should be known to the person committing the act, and both the defendant and the victim are at the time confined in a state hospital for the care and treatment of the mentally disordered or in any other public or private facility for the care and treatment of the mentally disordered approved by a county mental health director, shall be punished by imprisonment in the state prison, or in a county jail for not more than one year. Notwithstanding the existence of a conservatorship pursuant to the Lanterman-Petris-Short Act (Part 1 (commencing with Section 5000) of Division 5 of the Welfare and Institutions Code), the prosecuting attorney shall prove, as an element of the crime, that a mental disorder or developmental or physical disability rendered the alleged victim incapable of giving legal consent."

#### AB 71 (Chiu D) - Income taxes: credits: low-income housing: farmworker housing

Current Text: Amended: 3/2/2017 Location: 3/8/2017-A. REV. & TAX

Would, under the law governing the taxation of insurers, the Personal Income Tax Law, and the Corporation Tax Law, for calendar years beginning in 2018, increase the aggregate housing credit dollar amount that may be allocated among low-income housing projects to \$300,000,000, as specified, and would allocate to farmworker housing projects \$25,000,000 per year of that amount. The bill would delete that special needs exception and authorization to request state credits provided the applicant is not requesting a 130% basis adjustment for purposes of the federal credit amount.

AB 74 (Chiu D) - Housing

Current Text: Introduced: 12/16/2016 Location: 3/21/2017-A. APPR.

Would require Department of Housing and Community Development to, on or before October 1, 2018, establish the Housing for a Healthy California Program and on or before April 1, 2019, and every year thereafter, subject to on appropriation by the Legislature, award grants on a competitive basis to eligible grant applicants based on guidelines that HCD would draft, as prescribed, and other requirements. The bill would provide that an applicant is eligible for a grant under the program if the applicant meets specified requirements.

#### AB 177 (Chávez R) – Child abuse and neglect: reporting

Current Text: Amended: 2/21/2017 Location: 1/30/2017-A. PUB. S.

Would require a social worker investigating a case of child abuse or neglect involving an allegation against the parent or guardian of the child to attempt to determine if the parent or guardian is a member of the military. The bill would provide that if it is determined that the parent or guardian is a member of the military, the social worker would be required to notify the Family Advocacy Program of the Department of Defense that there is an allegation of abuse or neglect that relates to the parent or guardian who is a member of the military.

## AB 275 (Wood D) – Long-term care facilities: requirements for changes resulting in the inability of the facility to care for its residents

Current Text: Amended: 3/28/2017

Location: 4/5/2017-A. APPR. Calendar: 4/26/2017 9 a.m. - State Capitol, Room 4202

Current law imposes various notice and planning requirements upon a long-term health care facility before allowing a change in the status of the license or operation of the facility that results in the inability of the facility to care for its patients or residents, including a requirement for written notification to the affected patients or their guardians at least 30 days prior to the change. This bill would expand the notice and planning requirements that a long-term health care facility provides before any change in the status of the license or in the operation of the facility that results in its inability to care for its residents.

#### AB 279 (Holden D) – Developmental disabilities: regional centers

Current Text: Amended: 3/1/2017

Location: 3/8/2017-A. APPR. Calendar: 4/26/2017 9 a.m. - State Capitol, Room 4202

Current law authorizes the State Department of Developmental Services to contract with regional centers to provide services and supports. Current law requires the department to adopt regulations that specify rates, calculated on the basis of a cost model, including, among other things, changes in the state or federal minimum wage, for community care facilities serving persons with developmental disabilities, as specified. This bill would require the cost model described above to also include changes in local minimum wage.

#### AB 286 (Gipson D) – Medi-Cal: beneficiary maintenance needs: home upkeep allowances: transitional needs funds.

Current Text: Amended: 3/21/2017

Location: 2/13/2017-A. APPR. Calendar: 4/26/2017 9 a.m. - State Capitol, Room 4202

Would establish eligibility and other requirements for providing the home upkeep allowance or a transitional needs fund to Medi-Cal patients residing in a long-term care facility, as specified. The bill would prescribe general requirements as well as specific requirements both for facility residents who intend to leave the facility and return to an existing home, who would receive the home upkeep allowance, and for residents who do not have a home but intend to leave the facility and establish a new home, who could establish a transitional needs fund for the purpose of meeting the transitional costs of establishing a home.

#### AB 316 (Waldron R) – Workforce development

Current Text: Amended: 4/5/2017 Location: 4/20/2017-A. APPR.

Current law requires the Employment Training Panel within the Employment Development Department to submit an annual report to the Legislature that contains summaries of information related to projects operated by the panel.

This bill would require the panel to solicit proposals and write performance-based contracts to fund projects that expedite and increase the number of middle-skill workers employed in an eligible industry. This bill would require projects funded by this program to comply with certain requirements.

AB 384 (Irwin D) - The Qualified ABLE Program: tax-advantaged savings accounts

Current Text: Introduced: 2/9/2017

Location: 4/24/2017-A. SECOND READING Calendar: 4/27/2017 #14 A. SECOND READING FILE

Current law requires that an ABLE account only be established for a designated beneficiary who is a resident of this state, and that the California ABLE Act Board market the program to residents of this state to the extent funds are available. This bill would expand the residency requirement for a designated beneficiary to being a resident of the United States, and as a result, would expand the purposes of a continuously appropriated fund, thereby making an appropriation.

AB 437 (Rodriguez D) – At-risk persons: first responders.

Current Text: Amended: 4/5/2017 Location: 4/18/2017-A. APPR.

Would require the Attorney General to establish and maintain within the Violent Crime Information Center a Voluntary Online At-Risk Community Network for purposes of providing information to first responders in order to prevent harmful interactions between first responders and seniors or persons with disabilities, as defined. The bill would prescribe the information that a senior, a person with a disability, a person with a limited conservatorship of a person with a developmental disability, or a parent of a minor child with a disability may voluntarily provide to the Attorney General for inclusion in the network, and prescribe how the network would be developed and communicated to the public, as specified.

AB 502 (Waldron R) - Crime victim compensation: elder or dependent adult financial abuse.

Current Text: Amended: 3/16/2017

Location: 4/5/2017-A. APPR. Calendar: 4/26/2017 9 a.m. - State Capitol, Room 4202

Would create the San Diego County Elder or Dependent Adult Financial Abuse Crime Victim Compensation Pilot Program to provide victims of elder or dependent adult financial abuse compensation to reimburse costs for financial counseling, mental health counseling, or supportive services, as specified, if the crime occurred in the County of San Diego.

AB 507 (Rubio D) – Resource families: preapproval training and annual training.

Current Text: Amended: 3/15/2017 Location: 3/21/2017-A. APPR.

Current law requires the Dept. of Social Services to implement a specified resource family approval process in all counties. Current law makes the counties responsible for, among other things, implementing the requirements for resource family approval and requiring resource families to complete a minimum of 8 hours of caregiver training annually. This bill would require each entity responsible for approving a resource family to work with that resource family to develop a training plan that, among other things, is child or youth informed and is based on the specific case plans, goals, and needs of each child or youth in the home.

AB 516 (Maienschein R) – Sex offenses: disabled victims.

Current Text: Introduced: 2/13/2017

Location: 3/21/2017-A. APPR. Calendar: 4/26/2017 9 a.m. - State Capitol, Room 4202

Current law, as amended by Proposition 83, the Sexual Predator Punishment and Control Act (Jessica's Law), approved by the voters at the November 7, 2006, statewide general election, makes a defendant subject to imprisonment in the state prison for 25 years to life if convicted of certain crimes. This bill would add the crimes of rape, sexual penetration, sodomy, and oral copulation, perpetrated against a person who is incapable, because of a mental disorder or developmental or physical disability, of giving legal consent, to the above provisions, if the victim is developmentally disabled, as defined.

#### AB 689 (Obernolte) – Juvenile Competency

Current Text: Amended: 3/16/2017

Location: 3/21/2017-A. APPR. Calendar: 4/26/2017 9 a.m. - State Capitol, Room 4202

Current law authorizes, during the pendency of any juvenile proceeding, the minor's counsel or the court to express a doubt as to the minor's competency. Existing law requires the court to appoint an expert, as specified, to evaluate whether the minor suffers from a mental disorder, developmental disability, developmental immaturity, or other condition and, if so, whether the condition or conditions impair the minor's competency. This bill would revise and recast these provisions to, among other things, expand upon the duties imposed upon an expert during his or her evaluation of a minor whose competency is in doubt, as specified.

#### AB 727 (Nazarian D) - Mental Health Services Act: housing assistance

Current Text: Introduced: 2/15/2017 Location: 4/20/2017 – SENATE RULES COMMITTEE

Current law specifies the manner in which counties are to use the funds distributed from the Mental Health Services Fund, including using the majority of the funds for services provided by county mental health programs. Existing law specifies a target population for these programs, including seriously emotionally disturbed children or adolescents and adults or older adults who have a serious mental disorder. This bill would clarify that counties may spend MHSA moneys on housing assistance, as defined, for people in the target population.

#### AB 806 (Kalra D) - Personal income taxes: credit: family caregiver

Current Text: Amended: 3/20/2017

Location: 3/2/2017-A. REV. & TAX Calendar: 5/8/2017 2:30 p.m. - State Capitol, Room 126

This bill would allow a credit against those taxes for each taxable year beginning on or after January 1, 2018, in an amount equal to 50% of the amount paid or incurred by a family caregiver during the taxable year for eligible

expenses, as defined, not to exceed \$1,000. This bill would take effect immediately as a tax levy.

#### AB 879 (Grayson D) - Planning and zoning: housing element

Current Text: Amended: 4/20/2017

Location: 4/17/2017-Assembly Local Government Calendar: 4/26/2017 1:30 p.m. - State Capitol, Room 447 The Planning and Zoning Law requires a city or county to adopt a general plan for land use development within its boundaries that includes, among other things, a housing element. That law requires the housing element to include an analysis of potential and actual nongovernmental constraints upon the maintenance, improvement, or development of housing for all income levels, including the availability of financing, the price of land, and the cost of construction. This bill would require this analysis to also include the requests to develop housing at densities below those anticipated in a specified analysis, and the length of time between receiving approval for a housing development and submittal of an application for building permits for that housing development that hinder the construction of a locality's share of the regional housing need.

#### AB 935 (Stone, Mark D) – Juvenile proceedings: competency

Current Text: Amended: 4/6/2017

Location: 3/27/2017-A. PUB. SAFETY Calendar: 4/25/2017 9 a.m. - State Capitol, Room 126

Upon suspension of proceedings, existing law requires the court to order that the question of the minor's competence be determined at a hearing. Current law requires the court to appoint an expert, as specified, to evaluate whether the minor suffers from a mental disorder, developmental disability, developmental immaturity, or other condition and, if so, whether the condition or conditions impair the minor's competency. This bill would revise and recast these provisions to, among other things, expand upon the duties imposed upon the expert during his or her evaluation of a minor whose competency is in doubt, as specified.

AB 973 (Low D) – Remote accessible vote by mail system.

Current Text: Introduced: 2/16/2017 Location: 3/22/2017-A. APPR.

Would require a county elections official to permit a voter with a disability, or a military or overseas voter, to cast his or her ballot using a certified remote accessible vote by mail system. This requirement would become operative one year after the date on which the Secretary of State certifies a remote accessible vote by mail system.

#### AB 1006 (Maienschein R) – Foster youth.

Current Text: Amended: 4/3/2017 Location: 4/18/2017-A. APPR.

Would require, in any case in which the court has ordered a dependent child or a ward of the juvenile court placed for adoption or has appointed a relative or nonrelative legal guardian, the social worker or probation officer to provide the prospective adoptive family or the guardian or guardians specified mental health treatment information. The bill would also require the department, the county adoption agency, or the licensed adoption agency, to provide that information to the prospective adoptive family at the time the application for adoption is made and at the time immediately prior to the finalization of the adoption decree.

#### AB 1111 (Garcia, Eduardo D) - Removing Barriers to Employment Act

Current Text: Amended: 4/19/2017

Location: 3/9/2017-Assembly Jobs, Economic Dev't and Economy

Calendar: 4/25/2017 9 a.m.- Room 127

Would enact the Removing Barriers to Employment Act, which would establish the Breaking Barriers to

Employment Initiative within the Labor and Workforce Development Agency. The bill would require the initiative
to be led by the Secretary of Labor and Workforce Development and authorizes the secretary to assign all or part of
the administration of the initiative to one or more entities within the agency's oversight, or to authorize another state
agency, under specified conditions, to administer a portion of the initiative.

#### AB 1164 (Thurmond D) – Foster care placement: funding

Current Text: Amended: 4/18/2017 Location: 4/19/2017-A. APPR.

Would establish the Emergency Child Care Bridge Program for Foster Children (bridge program). The bill would authorize, contingent upon an appropriation of \$11,000,000 in the 2017–18 fiscal year and \$22,000,000 annually thereafter, county welfare departments to administer the bridge program and distribute vouchers, or payment, for child care and development services for an eligible child who is placed with an approved resource family, a licensed or certified foster family, or an approved relative or nonrelative extended family member, or who is the child of a young parent involved in the child welfare system.

#### AB 1193 (Gloria D) - Property tax: welfare exemption: low-income housing

Current Text: Introduced: 2/17/2017

Location: 3/9/2017-A. REV. & TAX Calendar: 5/8/2017 2:30 p.m. - State Capitol, Room 126

Would specify describe certain provisions of the Internal Revenue Code related to the determination of eligibility for a low-income housing tax credit under the Internal Revenue Code that also apply for the purposes of the welfare exemption.

#### AB 1316 (Quirk D) – Public health: childhood lead poisoning: prevention

Current Text: Amended: 4/18/2017

Location: 4/5/2017-A. HEALTH Calendar: 4/25/2017 1:30 p.m. - State Capitol, Room 4202

Currently, State Department of Public Health regulations require that all children are evaluated for risk of lead poisoning during each child's periodic health assessment. This bill would require the standard of care to be that all children be screened for blood lead levels, as specified, and would clarify that the lead screening would not be paid for by funds from the Childhood Lead Poisoning Prevention Fund.

AB 1322 (Bocanegra D) – Property taxation: intercounty base year value transfers

Current Text: Introduced: 2/17/2017

Location: 4/3/2017-A. APPR. Calendar: 4/26/2017 9 a.m. - State Capitol, Room 4202

Would authorize any person over 55 years of age or any severely and permanently disabled person to transfer the base year value of an original property to a replacement dwelling located in a different county without the adoption of a county ordinance so providing. The bill would limit this provision to transfers of base year value that occur on an effect forward 1, 2010.

or after January 1, 2019.

#### AB 1353 (Waldron R) - Health care coverage: prescription drugs: continuity of care

Current Text: Amended: 3/23/2017 Location: 3/13/2017-A. HEALTH

Requires health plans with prescription drug coverage to develop an exception process for people seeking outpatient

prescription drugs.

#### AB 1446 (Cooley D) - Dependent children: periodic review hearing

Current Text: Amended: 4/18/2017 Location: 4/18/2017-A. APPR.

Would require, in any case in which a dependent child or nonminor dependent is residing for more than 15 consecutive calendar days in emergency shelter care, a temporary shelter care facility, or a transitional shelter care facility, as defined, or due to the lack of placement is temporarily residing in a homeless shelter, hotel, or other similar facility, the court to periodically review the action taken by the social worker to locate a placement consistent with the case plan for the dependent child or nonminor dependent. The bill would require these periodic reviews to be held at least every 15 days and to include review of efforts made by the social worker to identify and locate adult relatives of the child or nonminor dependent.

#### AB 1607 (Frazier D) – Developmental services: integrated competitive employment

Current Text: Amended: 4/17/2017 Location: 4/17/2017-A. APPR.

Would authorize a consumer in a supported employment program or work activity program who has the stated goal of integrated competitive employment in his or her IPP to request to use tailored day services in conjunction with his or her existing program to achieve that goal, if specified criteria are met, including that the type, amount, and provider of tailored day service allowed under these provisions is determined through the IPP process. The bill would specify the maximum hours of tailored day services that may be authorized in conjunction with existing services under these provisions.

#### AB 1629 (Maienschein R) – Income taxes: credit: employees with disabilities.

Current Text: Amended: 4/18/2017

Location: 4/3/2017-A. APPR. Calendar: 4/26/2017 9 a.m. - State Capitol, Room 4202

This bill, for taxable years beginning on and after January 1, 2018, and before January 1, 2023, would allow a credit under the Personal Income Tax Law and the Corporation Tax Law to a qualified employer that pays or incurs to a qualified employee a wage equal to or exceeding the minimum wage during the taxable year, as provided.

#### SB 2 (Atkins D) – Building Homes and Jobs Act.

Current Text: Amended: 3/23/2017 Location: 4/3/2017-S. APPR. SUSPENSE FILE

Would enact the Building Homes and Jobs Act. The bill would make legislative findings and declarations relating to the need for establishing permanent, ongoing sources of funding dedicated to affordable housing development. The bill would impose a fee, except as provided, of \$75 to be paid at the time of the recording of every real estate instrument, paper, or notice required or permitted by law to be recorded, per each single transaction per single parcel of real property, not to exceed \$225.

#### SB 3 (Beall D) - Affordable Housing Bond Act of 2018

Current Text: Amended: 3/28/2017 Location: 4/3/2017-S. APPR. SUSPENSE FILE

Would enact the Affordable Housing Bond Act of 2018, which, if adopted, would authorize the issuance of bonds in the amount of \$3,000,000,000 pursuant to the State General Obligation Bond Law. Proceeds from the sale of these bonds would be used to finance various existing housing programs, as well as infill infrastructure financing and affordable housing matching grant programs, as provided.

#### SB 8 (Beall D) – Diversion: mental disorders

Current Text: Amended: 2/21/2017 Location: 4/3/2017-S. APPR. SUSPENSE FILE

Would authorize a court, with the consent of the defendant and a waiver of the defendant's speedy trial right, to postpone prosecution of a misdemeanor or a felony punishable in a county jail, and place the defendant in a pretrial diversion program if the court is satisfied the defendant suffers from a mental disorder, that the defendant's mental disorder played a significant role in the commission of the charged offense, and that the defendant would benefit from mental health treatment.

#### SB 147 (Dodd D) – Mobilehome parks: residency

Current Text: Amended: 4/17/2017

Location: 1/26/2017-S. JUDICIARY Calendar: 5/2/2017 1:30 p.m. - Room 112

Would make it easier for a person with a disability to have a caretaker live with them in a mobile home park.

#### SB 177 (Nguyen R) – Cognitively impaired adults: caregiver resource centers

Current Text: Amended: 4/3/2017 Location: 4/17/2017-S. APPR. SUSPENSE FILE

Would appropriate \$3.3M GF for the Department of Health Care Services to fund the existing statutory authority those centers have to provide respite for caregivers of cognitively impaired adults.

#### SB 192 (Beall D) – Mental Health Services Act Reversion Fund

Current Text: Amended: 4/18/2017 Location: 4/18/2017-S. APPR.

Would amend the Mental Health Services Act by requiring that any funds allocated since the 2008–09 fiscal year, except as specified, that have not been spent for their authorized purpose within 3 years of being allocated, and any interest earned on unspent funds, revert to the state for deposit into the newly established Mental Health Services Act Reversion Fund. The bill would authorize a very small county to apply for a waiver requesting a delay, but not for more than 5 fiscal years from the time of allocation of funds.

#### SB 202 (Dodd D) – Medi-Cal: beneficiary maintenance needs: personal needs allowance

Current Text: Introduced: 1/31/2017 Location: 4/20/2017-S. APPR.

Would increase the personal needs allowance amount from \$35 to \$80 per month of a medically needy individual who is in a medical institution or nursing facility, or a person receiving institutional or noninstitutional services from a Program of All-Inclusive Care for the Elderly organization.

#### SB 218 (Dodd D) - The Qualified ABLE Program: tax-advantaged savings accounts

Current Text: Amended: 4/19/2017

Location: 4/17/2017-S. APPR. Calendar: 5/1/2017 10 a.m. – Room 4203

Would authorize the transfer of all amounts in the designated beneficiary's ABLE account to an ABLE account for another individual specified by either the designated beneficiary or the estate of the designated beneficiary upon the death of the designated beneficiary. The bill would prohibit the state from seeking recovery under the Medi-Cal estate recovery provisions of any amount remaining in the designated beneficiary's ABLE account for any amount of medical assistance paid under the state's Medicaid plan, unless the federal Centers for Medicare and Medicaid Services determines this provision is inconsistent with federal law, and would prohibit the state from filing a claim for the payment under the ABLE Act.

SB 323 (Mitchell D) – Medi-Cal: federally qualified health centers and rural health centers: Drug Medi-Cal and specialty mental health services.

Current Text: Amended: 4/6/2017

Location: 4/24/2017-S. SECOND READING Calendar: 4/27/2017 #16 SECOND READING FILE

Would prohibit the costs associated with providing Drug Medi-Cal services or specialty mental health services from being included in the FQHC's or RHC's per-visit PPS rate, and would require the costs associated with providing Drug Medi-Cal services or specialty mental health services to be adjusted out of the FQHC's or RHC's clinic base rate as a scope-of-service change if the FQHC or RHC determines that the costs associated with providing Drug Medi-Cal services or specialty mental health services are within the clinic base rate, as specified.

#### SB 374 (Newman D) – Health insurance: discriminatory practices: mental health.

Current Text: Amended: 4/3/2017 Location: 4/24/2017-A. DESK

Would require large group, individual, and small group health insurance policies to provide all covered mental health and substance use disorder benefits in compliance with those provisions of federal law governing mental health parity. The bill would authorize the Insurance Commissioner to issue guidance to health insurers, until January 1, 2019, regarding compliance with these requirements.

SB 398 (Monning D) – Acquired brain trauma

ARCA Position: Support

Current Text: Amended: 4/6/2017

Location: 4/17/2017-S. APPR. Calendar: 5/1/2017 10 a.m. – Room 4203

Current law authorizes the Department of Rehabilitation to make grants from the funds in the Traumatic Brain Injury Fund to service providers for the purpose of carrying out the program and requires the department to pursue all sources of federal financial participation. Current law makes these provisions inoperative on July 1, 2019. This bill would instead make that program operative indefinitely.

#### SB 416 (Anderson R) – Elder abuse: isolation

Current Text: Introduced: 2/15/2017

Location: 2/23/2017-S. PUBLIC SAFETY Calendar: 4/25/2017 8:30 a.m. - Room 3191

Current law requires a person who proximately causes the death of the victim during the commission of that crime to serve an additional 5 years in prison if the victim is under 70 years of age, and an additional 7 years in prison if the victim is 70 years of age or older. Existing law requires the court, upon a conviction for elder abuse, to consider issuing an order restraining the defendant from any contact with the victim, as specified. The bill would require a person who causes great bodily injury to the victim during the commission of the above-specified crime to serve 5 additional years in prison, regardless of the age of the victim, and would require a person who proximately causes the death of the victim during the commission of the above-specified crime to serve 7 additional years in the state prison, regardless of the age of the victim.

#### SB 433 (Mendoza D) – Developmental services: data exchange

Current Text: Amended: 3/29/2017

Location: 4/18/2017-S. THIRD READING Calendar: 4/27/2017 #39 THIRD READING FILE Would authorize the Employment Development Department to disclose specified information to the State Department of Developmental Services, upon request, through information-sharing agreements or data interfaces to assist the State Department of Developmental Services in the implementation of the Employment First Policy and to support consumers in the achievement of competitive integrated employment. The bill would subject the disclosure of this information to various privacy laws. By expanding a crime under these provisions, this bill would impose a statemendated local program.

SB 499 (Stone R) - Developmental services: regional centers

Current Text: Introduced: 2/16/2017

Location: 3/2/2017-S. HUM. S. Calendar: 4/25/2017 1:30 p.m. - Room 3191

Would require the State Department of Developmental Services to increase the funding provided to a regional center to enable the regional center and the regional center's purchase-of-service vendors to fund certain costs related to

minimum wage requirements.

#### SB 612 (Mitchell D) - Foster care: transitional housing

Current Text: Amended: 4/17/2017

Location: 3/2/2017-S. HUM. S. Calendar: 4/25/2017 1:30 p.m. - Room 3191

The California Community Care Facilities Act requires the State Department of Social Services to license and regulate transitional housing placement providers as a community care facility, and requires transitional housing to include, among others, programs in which a participant lives independently in an apartment, single-family dwelling, or condominium owned or leased by the provider either with an adult employee of the provider or in a building in which one or more adult employees of the provider reside and provide supervision. This bill would, among other things, change the above-described program that requires one adult employee of the provider to reside with the participant or one or more adult employees to reside in the building and provide supervision to instead authorize one or more adult employees to either reside in the building or provide supervision.

#### SB 770 (Glazer D) - Violent felonies

Current Text: Introduced: 2/17/2017 Location: 3/9/2017-S. PUB. SAFETY

Current law classifies certain felonies as violent felonies for purposes of various provisions of the Penal Code. This bill would amend the above initiative statutes by defining additional crimes, including, among others, human trafficking, elder and dependent adult abuse, assault with a deadly weapon, rape under specified circumstances, discharge of a firearm at an occupied building, and specified crimes against peace officers and witnesses, as violent felonies for purposes of the above specified sentence enhancements.

#### SCR 22 (Hueso D) – Autism Awareness Month.

Current Text: Introduced: 2/14/2017

Location: 4/24/2017-S. THIRD READING Calendar: 4/27/2017 #55 THIRD READING FILE

This measure would designate the month of April 2017 as Autism Awareness Month and would encourage residents to show support for autism awareness.

Intake: I am pleased to report that we have hired our two new growth positions, Senior Intake Counselors to help with the heavy load of conducting the Social Assessments and managing the Intake cases. In additional to that, our two new vendors working are working out very well as they conduct Social Assessments and provide the very important and much needed reports on a timely basis. The goal is to make the intake process as streamlined as possible as we endeavor to meet or beat our regulation timelines.

**Early Start Clinic**: The Early Start Clinic has been busy and a new Infant Services Coordinator was hired into the position left vacant by Kathy Smith's passing.

Early Start: The Early Start Units are preparing for a DDS Audit in July, 2017. In addition to that, the Early Start Units are officially in "Cohort II", as we look toward working with the "State Systemic Improvement Plan" (SSIP) focusing on consistently measuring the development of the Social and Emotional well-being of the little individuals we service.

#### Family Resource Network: The purpose of the FRN is to

- Provide supportive services which include education, resources, and training to families with children who are at risk for or are experiencing delays or disabilities
- Enhance parent awareness by linking families with appropriate services in their communities
- Promote parent and professional collaboration by acknowledging the family's central role in all aspects of the decision--making process and utilizing their strengths
- Provide a coordinated network of parent to parent support throughout the Riverside and San Bernardino Counties in California.

Clinical Services: Our Clinical Services Team is busy assessing eligibility as well as assisting with coordinating Nutritional and Dental services, Occupational Therapy, Physical Therapy, Pharmacology, and Medical/Nursing assessments.
